#### **Educational Tours**

# ADDITIONAL INFORMATION

Please take note of the following:

- 1. SD number must be used as a reference for all payments made part from the application and enrolment fee which requires you to use your AP number.
- 2. Fees are payable in advance on or before the first of every month.
- 3. To qualify for the annual upfront discount, fees need to be paid in full by 15 January 2024.
- 4. Should the annual upfront plan be selected by the fee payer during the registration process, but the full annual amount not paid by **15 January 2024**; this will result in the account being automatically defaulted to the 10-monthly plan with the monthly instalment becoming due immediately. If the 12-month payment plan is selected we request parents to pay via debit order.
- 5. Sibling discounts will be applied as follows:
  - 0% for the eldest sibling
  - 5% for the 1<sup>st</sup> sibling,
  - 10% for the 2<sup>nd</sup> sibling, and
  - 15% for the 3<sup>rd</sup> sibling onwards.
- 6. Maragon Schools will be using the Pinnacle Colleges Public Beneficiary Bank Account. Pinnacle Colleges are now listed as a Public Beneficiary with most major banks and can be found by searching for Pinnacle Colleges on your online banking platform.
- 7. Please refer to the information pack for your relevant grade for more detail on and other services offered and their relevant pricing.
- 8. Should you join after 31 January a pro-rata fee and alternative payment plan will apply.
