WHEREAS, the Parties have reviewed and agreed to the rate schedule attached to this Extension Agreement, and

WHEREAS, the Parties have this date agreed to extend the Term of the Agreement to March 31, 2025.

For and in consideration of the mutual benefits and other good and valuable consideration herein, it is hereby agreed as follows:

- 1. The above Agreement shall be extended to the 31st day of March, 2025.
- 2. That the attached Exhibit A shall be incorporated into the Agreement as the rate schedule for the services to be provided under the Agreement effective March 29, 2023
