

2024 AGREEMENT BETWEEN GRAYS HARBOR COUNTY AND GRAYS HARBOR TRANSIT FOR RADIO EQUIPMENT MAINTENANCE

This Agreement (“Agreement”) is made between Grays Harbor County and its Department of Public Services Equipment Rental and Revolving Division (collectively, the “County”) and Grays Harbor Transit (“Agency”) for radio equipment maintenance.

In consideration of the mutual promises herein, the parties agree as follows:

1. The County shall provide the services necessary for the purpose of maintaining all two-way radio systems and associated electronics gear for the Agency, both in transit vehicles and as described in the Communication Site Lease Agreement Between Grays Harbor County and Grays Harbor Transit Authority, which is incorporated herein by reference.
2. The Agency shall pay the County \$833 each month for the services described in Section 1.
3. The Agency shall hold the County, its agents, and employees harmless from all claims, losses, demands, actions, or causes of action of any nature whatsoever by reason of the performance of this Agreement by the County. The Agency shall defend, at its own expense, the County in the event that any action is brought against the County as a result of any act or activity of the County, its agents, or employees because of or in any way arising out of the work performed under this Agreement. The Agency’s obligations under this section will survive the termination of this Agreement.
4. No party may assign any of its rights or delegate any of its duties without the other party’s written consent. Any purported assignment or delegation in violation of this section is void.
5. This Agreement begins on January 1, 2024, and ends on December 31, 2024. Any party may request to negotiate this Agreement for an additional one-year term, provided that the party making such request provides sixty (60) days’ written notice to the other party. Such negotiation may include changes in services or pricing based upon a review of the previous year.
6. Any party may terminate this Agreement at any time and for any reason by delivering thirty (30) days’ written notice to the other party.
7. The parties may amend this Agreement at any time by executing a written amendment signed by both parties.
