TRAFFIC VIOLATIONS

"Minor" Traffic Violations as defined in Section 479.350 RSMO. (Aug 28, 2016)

C&I w/o Accident	\$191.50, \$33.50 cost, 2 yr probation, 30 days SES
Def Equip	\$191.50, \$33.50 cost, 2 yr probation, 30 days SES
FDSL	\$191.50, \$33.50 cost, 2 yr probation, 30 days SES
Failure to Register	\$191.50, \$33.50 cost, 2 yr probation, 30 days SES
Failure to Signal	\$191.50, \$33.50 cost, 2 yr probation, 30 days SES
Failure to Stop @ Stop Sign	\$191.50, \$33.50 cost, 2 yr probation, 30 days SES
Invalid License Plates	\$191.50, \$33.50 cost, 2 yr probation, 30 days SES
Invalid Operators License	\$191.50, \$33.50 cost, 2 yr probation, 30 days SES
Minor in possession	\$191.50, \$33.50 cost, 2 yr probation, 30 days SES
No Operator's license	\$191.50, \$33.50 cost, 2 yr probation, 30 days SES
No proof of insurance	\$191.50, \$33.50 cost, 2 yr probation, 30 days SES
Open Container	\$191.50, \$33.50 cost, 2 yr probation, 30 days SES

Note: Any of the above fines may increase up to \$500 and include programs to be ordered if:

- (a) There was an accident or injury
- (b) Involves operation of a commercial vehicle

Speeding

1-25 MPH Over	\$100.00 base + \$4 per mile over, 2 yr probation, 30 days SES
26 MPH & Over	\$200.00 + \$4 per mile over, 2 yr probation, 30 days SES, DIP w/in 60 days
School or Construction Zone	\$350.00 base + \$4 per mile over, 2 yr probation, 30 days SES, DIP w/in 60 days

No Safety Restraint

No child safety restraint	\$25.00 plus costs, plus 2 yr probation, 30 days SES
No Seatbelt	\$10.00 (no court costs)

Motorcycle

No Motorcycle Endorsement	\$191.50, \$33.50 cost, 2 yr probation, 30 days SES

Traffic Violations NOT subject to Section 479.350 RSMO. (Aug 28, 2016)

DWI/BAC	\$500 fine, \$33.50 cost, 2 yr probation, 60 days SES, SATOP, LIFE, DIP, w/in 60, in most cases there is also a \$40 recoupment fee
C&I w/ Accident	\$500 fine, \$33.50 cost, 2 yr probation, 30 days SES, DIP and LIFE w/in 60 days
DWS/DWR	\$300 for 1 st offense, \$33.50 cost, 2 yr probation, 60 days SES \$500 for 2 nd and more
Leaving the Scene	\$500 fine, \$33.50 cost, 2 yr probation, 60 days SES

NON-TRAFFIC VIOLATIONS

Animal Neglect	\$350 fine, \$33.50 cost, 2 yr probation, 30 days SES
Assault	\$500 fine, \$33.50 cost, 2 yr probation, 30 days SES
Bad check	\$400 fine, \$33.50 cost, 2 yr probation, 30 days SES, plus restitution
Deceiving Police	\$250 fine, \$33.50 cost, 2 yr probation, 30 days SES
Disorderly Conduct	\$500 fine, \$33.50 cost, 2 yr probation, 30 days SES, Anger Mgt w/in 60 days
Dog at Large -	\$191.50, \$33.50 cost, 2 yr probation, 30 days SES
Endangering Welfare	\$500 fine, \$33.50 cost, 2 yr probation, 30 days SES
Harassment	\$400 fine, \$33.50 cost, 2 yr probation, 30 days SES
Illegal Burning	\$191.50, \$33.50 cost, 2 yr probation, 30 days SES
Littering	\$100 fine, \$33.50 cost, 2 yr probation, 30 days SES
Peace Disturbance	
No assault	\$250 fine, \$33.50 cost, 2 yr probation, 30 days SES
w/assault	\$500 fine, \$33.50 cost, 2 yr probation, 30 days SES, complete Anger Management in 60 days
Possession of CS	\$350.00 for 1 st , \$33.50 cost, 2 yrs probation, 30 days SES, DAEP to be completed in 60 days \$500 for 2 nd and more
Possession of Marijuana	\$350.00 for 1 st , \$33.50 cost, 2 yrs probation, 30 days SES, DAEP to be completed in 60 days \$500 for 2 nd and more
Poss Drug Paraphernalia	\$350.00 for 1 st , \$33.50 cost, 2 yrs probation, 30 days SES. DAEP to be completed in 60 days \$500 for 2 nd and more
Property damage	Up to \$500 fine, \$33.50 cost, 2 yrs probation, 30 days SES
Public intoxication	\$400 fine, \$33.50 cost, 2 yrs probation, 30 days SES

Resisting arrest	
Flight	\$400 fine, \$33.50 cost, 2 yrs probation, 30 days SES
Physical	\$500 fine, \$33.50 cost, 2 yrs probatin, 60 days SES, complete Anger Management in 60 days
Stealing	\$350.00 for 1st, \$33.50 cost, 2 yrs probation, 60 days SES and restitution \$500 for 2 nd and more
Trespass	\$250.00 for 1st, \$33.50 cost, 2 yr probation 30 days jail SES \$500 for 2 nd and more

NUISANCE AND OTHER ZONING-RELATED VIOLATIONS

64.295	P&Z- violation of zoning regulations
64.487	Unlawful Dumping

1 st offense:	\$166.50 fine, \$33.50 costs (\$200.00 total)
2 nd offense:	\$241.50 fine, \$33.50 costs (\$275.00 total)
3 rd offense:	\$266.50 fine, \$33.50 costs (\$300.00 total)
4 th offense:	\$366.50 fine, \$33.50 costs (\$400.00 total)
