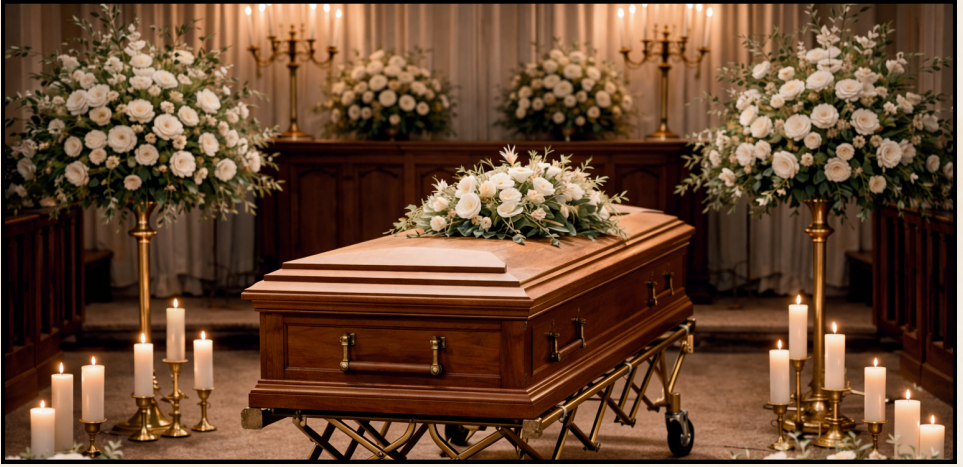
No additional warranties are provided by us. This includes any implied warranties of merchantability or fitness for a particular purpose.

ITEMIZED SERVICE FEE

This list is provided pursuant to the requirements of the Federal Trade Commission, we offer the following breakdown of our individual prices:

BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF \$1795

Service charge includes 24-hour availability, services of arrangement counselor and other staff assistance, preparation of death certificate and regulatory permit, and coordination of final disposition with cemetery, crematory and/or other parties involved with final disposition. In addition, this fee includes a proportionate share of our basic overhead costs. This fee for our services and overhead will be added to the total cost of the funeral arrangements you select. This fee is declinable and is already included in our charges for direct cremation, immediate burials, and forwarding or receiving of remains. It is also included in all other plans offered herein.

EMBALMING \$995

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement which does not require you to pay for it, such as Direct Cremation or Direct Burial.

Under California law, refrigeration or embalming is required if final disposition does not occur within 24 hours.

FORWARDING DECEDENT TO ANOTHER FUNERAL HOME \$2595

Includes adjusted fee basic services of funeral director and staff, transfer of decedent to funeral home, processing and obtaining the death certificate and required permits, embalming, coordination with receiving funeral home and common carrier, and local transportation in utility vehicle to common carrier. This charge does not include common carrier charges, merchandise, ceremonies, rites, or viewings.

RECEIVING DECEDENT FROM ANOTHER FUNERAL HOME \$2395

Includes adjusted fee for basic services of funeral director and staff, transportation from common carrier to funeral home, securing necessary authorizations, coordination with cemetery, temporary shelter of decedent, and local transportation to the cemetery. This charge does not include ceremonies, rites, or viewings.

DIRECT CREMATION \$2095

Includes adjusted fee for services of funeral director and staff, transfer of decedent to funeral home (within a 30-mile radius), securing necessary authorizations and legal documentation, refrigeration for up to 14 days, and the actual cremation charge.* If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials such as fiberboard or composition materials (with or without an outside covering). The alternative containers we offer are made of heavy cardboard.

(This does not include viewing, ceremony, or witnessed burial, and it will take place at a time determined by the mortuary.)

*There is no legal requirement for a family to arrange a formal funeral procession. However, if a family chooses to have one, state guidelines outline the proper use of motorcycle escorts. For safety purposes, the Highway Patrol recommends one (1) motorcycle escort for every eight (10) vehicles in the procession, with a minimum of two (2) escorts required. The number of escorts needed must be estimated during the arrangement conference. Please note that if the size of the procession increases on the day of the service, additional escorts will be assigned as necessary. Any additional escorts required for safety will incur a fee of \$250.00 per escort.
