Update from the Church Board – by Wanda Bates

Our monthly board meeting was held on Wednesday evening, May 12th, and as a group we feel that it is important to keep communications open so that all of you are up to date with the work and decisions of our new community of faith. As always, your feedback and suggestions are most welcome at any time.

Amalgamation Update

There is always news to report regarding our new amalgamated community of faith:

- The sale of Ballinafad Church closed during the first week of May. Our thanks are extended to Dave Shortt, Chair of the Church Trustees, and his committee members Marilyn Linstead and Dan Rohde. They are to be commended for their work through the lengthy and emotional sale process. The church will be enjoyed by an Indonesian faith group out of Mississauga.
- Money from the sale of the church (\$475,000) has since been deposited in a new account for our amalgamated church. This money is "restricted", meaning that it is generally NOT to be used for operating expenses, but could be used for capital and/or mission projects. A proposal/request must be sent to John Neff, our Regional Council contact, for approval. The interest on this money comes directly to our church to use as we see fit.
- We are anxious to INVEST this money as soon as possible, and will be arranging a meeting of the treasurers, finance committee members, and the Church Trustees as soon as possible to discuss our financial goals, church needs, and possible investment strategies. If any of you have suggestions regarding financial advisors or investment opportunities...please feel free to share your ideas with us! For example, Cathy Hansen, suggested Solar Shares as an investment a few years ago, and we still invest with them at an annual return of 4.5% which is very good return at the present time.
- The FINAL step of the paperwork submissions was the preparation of a Position (Job) Description for the minister, which is based on the Living Faith Story we presented to you following our annual meeting in February (which was officially approved in March). We feel that the Job Description reflects our present and future needs. This description was approved by the board on Wednesday evening and will be forwarded to the Human Resources Commission for their approval at their meeting next week. Once approved, it will be used to "call" a new minister as Felicia retires at the end of this year.

The Search and Selection of a New Minister

The governing body (our Church Board) is responsible for arranging a SEARCH TEAM who will assume the responsibility of finding a new minister. The size and make-up of the team is flexible, although we are suggesting that FIVE people might be ideal. Please consider taking a role in this important work. Training and resources are readily available. A new database has been developed called ChurchHub. It is a place where we will be posting our Living Faith Story and Position Description, and ministry candidates can sign in to the see the posted openings.
