Any excavation, filling or other work required by the Owner other than the usual and customary excavation and grading shall be an additional expense of the Owner. Owner shall determine before construction begins if additional site work is required because of the soil conditions at eh Work Site and shall provide Contractor written specifications as to such additional site work. Contractor shall not be responsible for any damages suffered by Owner because of the soil conditions at the Work Site.

7. INSURANCE:

- A. Contractor shall maintain general liability and workers compensation insurance to ensure against risks covered by such insurance. Contractor shall be responsible for any worker's compensation coverage or payments required and shall indemnify and hold Owner harmless for the payment of same or such claims against Owner.
- B. Owner shall maintain builder's risk insurance to ensure against risks covered by such insurance.
- **8. CHANGES TO SCOPE OF WORK:** Owner may make changes to the scope of the work including changes to the plans and specifications from time to time during the construction of the Project. However, any such change or modification shall only be made written "Change Order", in the form of a letter to Contractor specifying the changes. Owner agrees to pay any increase in the cost of the Project as a result of all Change Orders. In
