



REACHnet includes data from Baylor Scott & White Health, DHR Health, LCMC Health, Ochsner Health, Ochsner LSU Health Shreveport, Sutter Health, Tulane Medical Center, and University of California San Francisco health systems.

REACHnet contains data for 14,658,997 unique patients with at least one encounter in a partner health system from January 1, 2020, to December 31, 2024. Patient records are linked across health systems. The patient count is deduplicated for the network.
