

## Terms and conditions

### The Practice Room Membership

Iyengar Yoga Dunedin agrees to provide The Practice Room members with limited access to the studio, outside of studio class hours, and Practice Videos, as detailed in these Terms and Conditions.

Throughout the Terms and Conditions, the **Facility** is referred to as Iyengar Yoga Dunedin's studio located in Moray Chambers, Level 2, 30 Moray Place, Dunedin. Iyengar Yoga Dunedin is owned and operated by Demelza Campbell.

#### General

A member is granted access to use Iyengar Yoga Dunedin's facilities, outside of studio class hours, private lessons and workshops.

Membership entitles the member to reasonable use of the yoga practice facilities and equipment only.

Membership entitles the member access to recorded Practice Room videos. Videos are owned by Iyengar Yoga Dunedin, and not to be shared, or viewed by non-members, without their consent.

Start date of membership is the Monday following the first payment.

End date of membership is at least three months following the start date unless you choose to continue your membership.

Minimum membership period is 3 months, or 6 x fortnightly payments, and is automatically renewed every 3 months, unless cancelled a minimum of 7 days prior to end date.

Cancellation of a membership will be effective from the end of the current three-month membership period.

Price of membership is \$85.00NZD (The Practice Room) per fortnight, payable in advance, and non-refundable.

No Refunds after the commencement of a membership.

Pausing your membership: You can pause your membership if you are going away or unable to attend due to serious illness or injury. Prior notice must be given. This can be done once during a 6 month membership period.

All members must attend a 10-minute induction prior to their membership commencing. This covers Health & Safety, security, and etiquette. Members must follow The Practice Room requirements, and these are displayed at the facility as a courtesy and reminder.

All members will keep Iyengar Yoga Dunedin informed of your current email details, and agree to be kept informed of any changes or updates to The Practice Room membership.

### **Facility Hours and Access**

Hours of use are limited to outside of timetabled classes, private lessons and workshops.

Access details to the premises outside of studio class hours, is granted to Members only, and details are not to be shared with anyone.

The facility is free from the use of alcohol, vaping and smoking. Food may not be consumed inside the studio.

All heaters and lights must be turned off when leaving the premises, unless there is a sign indicating it can be left on.

The use of the facility is solely for the purpose of practising Iyengar Yoga.

### **Privacy**

Any personal information is protected by our Privacy Policy. Members may not view any other's personal information that may be stored at the facility.

### **Exclusions**

Membership does not include the use of the television or sound equipment at the facility.

Membership does not include use of any books or items that are for sale or display within the facility.

Workshops and associated videos are not included in the price of membership.

Iyengar Yoga Dunedin does not guarantee every studio class will be recorded and made available for members.

### **Prices and Payments**

Price of membership may change from time-to-time, and a minimum notice period of one month, will be given before any price change.

An automatic payment is to be set up before your membership commences.

Memberships start on a Monday. Payments are due on a Thursday each fortnight.

Failed payments: A \$9.80 fee will apply to all failed payments.

### **Health and Safety**

All members accessing The Practice Room must assume full responsibility for their practice and well-being, including managing any pre-existing condition. They will not undertake any asana or other activity which may present a risk to their health and wellbeing.

All members must undertake to keep Demelza updated with any details of any injury or medical condition that may impact their practice of yoga.

## **Responsibility**

Each member is solely responsible for their personal belongings and safety whilst they are a member of The Practice Room, Iyengar Yoga Dunedin. The Practice Room is for Members only, no guests may attend with the member.

Damage: Any damage to property is to be repaired or replaced as appropriate, by the person responsible for the damage.

Noise: Members must respect the enjoyment of others practising, as well as those in nearby homes and businesses, and limit any noise to a respectful amount.

Legal activities: Members must not carry out any illegal activities whilst at the facility.

Videos or Photos are not permitted to be taken whilst at the facility.

Memberships start on a Monday. Payments are due on a Thursday each fortnight.

Membership is for a minimum of at least three months.

## **Illness Policy**

Please do not attend the facility if you have any Covid, cold or flu symptoms, or if someone you live with currently has Covid. If you are visibly unwell whilst attending the facility you may be asked to leave.
