A Special Meeting of the Board of Emergency Services Commissioners of Milam County Emergency Services District No. 1 was held on Monday, September 29th, 2025, 6:00 P.M. at the Milano Civic Center, 120 W Ave E, Milano, TX 76556.

Taxpayer Impact Statement

For the 2024 tax year, the median-valued homestead property in Milam County Emergency Services District No. 1 had a taxable value of \$171,326. At a tax rate of \$0.10 per \$100 of taxable value, the property tax bill for this property was \$171.33. For the 2025 tax year, the median-valued homestead property in the District has a taxable value of \$183,130. At the proposed tax rate of \$0.089041 per \$100 of taxable value, the estimated property tax bill for this property is \$163.10.

If the District were to adopt a budget funded at the no-new-revenue tax rate of \$0.085822 per \$100 of taxable value, the estimated property tax bill for this property would be \$157.18. This comparison reflects a decrease from the 2024 tax bill, with the proposed 2026 budget lowering the typical tax burden by \$8.23 and the no-new-revenue rate lowering it by \$14.15.

This taxpayer impact statement is provided in accordance with the requirements of House Bill 1522 and is for comparison purposes only; it does not reflect the actual tax bill of any individual property owner.

- Public hearing on adoption of the proposed Milam County ESD No. 1 budget for 2026. This budget will raise more revenues from property taxes than last year's budget by an amount of \$121,252.22 which is a 3.5% increase from last year.

 President Kain Dodd called the public hearing to order at 6:02 p.m. and called to close the public hearing at 6:06 p.m. as no citizens present wished to speak.
- Discuss and take action to adopt the proposed Milam County ESD No. 1 budget for 2026. This budget will raise more revenues from property taxes than last year's budget by an amount of \$121,252.22 which is a 3.5% increase from last year.

 President Kain Dodd called the public hearing to order at 6:07 p.m. and called to close the public hearing at 6:08 p.m. as no citizens present wished to speak.
- Discuss and take action to adopt the proposed total tax rate of \$0.089041 per \$100 of taxable value, consisting of a maintenance and operations rate of \$0.089041 and an interest and sinking rate of \$0.000000.

 Commissioner Hanel made a motion that the property tax rate be decreased by the adoption of a tax rate of \$0.89041 per \$100 of taxable value, which is effectively a 10.96% decrease in the tax rate, consisting of a maintenance and operations rate of \$0.089041 and an interest and sinking rate of \$0.000000, seconded by Commissioner Reed, all were for, none were opposed, motion carried.
- Discuss and take any necessary action regarding PHI air ambulance membership benefits contract for 2026.

 PHI representative Dylan Newsom present along with a PHI Cares Membership representative. The membership representative presented the agreement. She reported the household count increased by 687 from last year bringing the agreement total to \$61,192.32 for 2026. She also reported that the upgrade price changed from \$30/yr to \$40/yr. She denied any other changes from this last year's agreement to the 2026 agreement. Dylan reported they have had a total of 25 completed flights from Milam County in 2025 with 52 requests. Commissioner Reed asked how many of those completed flights were from county residents and he did not have an answer at this time, but would get the information to the ESD board. Amendment is needed in section 5.5 of the agreement to change attorney information for the ESD board. Commissioner Reed

- made a motion to approve the PHI air ambulance membership benefits agreement (contract) for 2026 with attorney change amendment, seconded by Commissioner Knapek, Commissioner Gerren abstained, four were for, none were opposed, one abstained, motion carried.
- 9) Discuss and take any necessary action to adopt a resolution authorizing participation in the Texas SmartBuy Membership Program of the Texas Comptroller of Public Accounts.
