## **NOTICE OF SPECIAL MEETING**

In compliance with the provisions of Chapter 551, Texas Government Code, notice is hereby given of a special meeting of the Board of Emergency Services Commissioners of Milam County Emergency Services District No. 1 to be held at the Milano Civic Center, 120 W Ave E, Milano, TX 76556, Monday, September 29th, 2025, 6:00 P.M.

**Taxpayer Impact Statement** 

For the 2024 tax year, the median-valued homestead property in Milam County Emergency Services District No. 1 had a taxable value of \$171,326. At a tax rate of \$0.10 per \$100 of taxable value, the property tax bill for this property was \$171.33. For the 2025 tax year, the median-valued homestead property in the District has a taxable value of \$183,130. At the proposed tax rate of \$0.089041 per \$100 of taxable value, the estimated property tax bill for this property is \$163.10.

If the District were to adopt a budget funded at the no-new-revenue tax rate of \$0.085822 per \$100 of taxable value, the estimated property tax bill for this property would be \$157.18. This comparison reflects a decrease from the 2024 tax bill, with the proposed 2026 budget lowering the typical tax burden by \$8.23 and the no-new-revenue rate lowering it by \$14.15.

This taxpayer impact statement is provided in accordance with the requirements of House Bill 1522 and is for comparison purposes only; it does not reflect the actual tax bill of any individual property owner.

The District reserves the right to consider and take action on the above agenda items in any order. It also reserves the right to enter into a closed meeting on any agenda item as allowed by law. A Citizens Comment Form must be filed with the Secretary at least 10 minutes prior to the beginning of the meeting for an individual to be allowed to speak during Citizen Comment. By completing the Citizen Comment Form, the individual understands and acknowledges that the public is not

entitled to choose the items to be discussed by the Board of Emergency Services Commissioners. The individual executing the Citizen Comment Form understands that he/she is provided a limited amount of time, and that he/he may not be allowed to continue to address the Board of Emergency Services Commissioners if the comments are rude, disparaging or defamatory to any individual or entity, or the comments become disruptive to the good order of the meeting. If at a meeting of a governmental body, a member of the public or of the governmental body inquires about a subject for which notice has not been given as required by the Texas Open Meetings Act, the notice provisions of the Texas Open Meetings Act do not apply to a statement of specific factual information given in response to the inquiry; a recitation of existing policy in response to the inquiry; or, any deliberation of or decision about the subject of the inquiry shall be limited to a proposal to place the subject on the agenda for a subsequent meeting. It should be noted that pursuant to Section 38.13, Texas Penal Code, HINDERING PROCEEDINGS BY DISORDERLY CONDUCT: (a) A person commits an offense if he intentionally hinders an official proceeding by noise or violent or tumultuous behavior or disturbance; (b) A person commits an offense if he recklessly hinders an official proceeding by noise or violent or tumultuous behavior or disturbance and continues after explicit official request to desist; and, (c) An offense under Section 38.15, Texas Penal Code is a Class A misdemeanor.

## EXECUTIVE SESSION

At any time during the meeting, the Board of Emergency Services Commissioners may announce that it will go into closed session pursuant to Chapter 551 of the Texas Government Code to receive advice from legal counsel, to discuss matters of land acquisition, personnel matters, or other lawful matters that are specifically related to items listed on this agenda. Prior to any such closed session the President, in open session, will identify the agenda item to be discussed and the section or sections of Chapter 551 under which the closed discussion is authorized.
