- Specific roles and responsibilities of each proposed team member.
- Examples of past collaboration on similar projects.

Milam County ESD No.1

- Established by Voters Created in Nov. 2023 and operational since Jan. 2024 to provide stable, long-term EMS funding.
- Dedicated Funding Supported by property tax (up to \$0.10 per \$100) and potential sales tax; funds legally restricted to EMS.
- Local Oversight Governed by the District with authority to contract, own, and operate EMS equipment and facilities.
- Transparency & Accountability Independent annual audits filed with the County Commissioners Court.
- Our Vision Build a community focused EMS system through strategic planning, gradual asset acquisition, and long-term sustainability.



EMS STATION #1

- Project +/- 10,400 GSF arranged in three functional areas:



PROJECT SCHEDULE






PROJECT LOCATION
