## ***PROFESSIONAL SERVICES***

### **BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF, AND OVERHEAD \$3,400.00**

Our fee for the services of funeral director and staff includes, but is not limited to, staff to respond to initial request for service, arrangement conference with family or responsible party, preparation and filing of necessary authorizations and permits, recording vital statistics, preparation and placement of obituary notices, planning of funeral arrangements and coordination of service with those providing other portions of the funeral, e.g. cemetery, crematory and others as required. Also included in this charge are overhead expenses relative to our facility such as insurance, maintenance and utility expenses, secretarial and administrative costs, and equipment and inventory expenses.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, alkaline hydrolysis, immediate burials, and forwarding or receiving remains.)

### **EMBALMING \$750.00**

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial or when refrigeration or use of dry ice is available.

### **OTHER PREPARATION OF THE BODY**

### **VISITATION EACH HOUR PRIOR TO SERVICE \$150.00**

### **FUNERAL SERVICE AT GEARTY-DELMORE CHAPEL, CHURCH OR OTHER FACILITY \$775.00**

Our services include the supervision of funeral service, necessary staff to attend the funeral service, equipment to setup for service.

### **MEMORIAL SERVICE AT GEARTY-DELMORE CHAPEL, CHURCH OR OTHER FACILITY \$745.00**

Our services include the administration and supervision of the memorial service, necessary staff to attend the memorial service and equipment to setup for the memorial service.

### **GRAVESIDE SERVICE \$195.00**

Our services include the administration and supervision of the graveside service.

### **RECEPTION WAITING TIME \$200.00**

This is an additional charge for the reception to take place between the service and burial.

This charge includes our basic professional services of staff, removal and shelter of remains, embalming, filing the death certificate and issuing permits, transportation to airport or railroad depot, and receptacle for shipping. This fee does not include any services of the staff for funeral services or viewing prior to forwarding the body.

**RECEIVING OF REMAINS FROM ANOTHER FUNERAL HOME****\$2,495.00**

This charge includes basic professional services of staff, shelter of remains, transportation from airport or railroad depot, transportation to local cemetery or crematory. This fee does not include any services of the staff for funeral services or viewing.

**CHAPEL RENTAL FOR MEMORIAL SERVICE OR VISITATION****\$2,195.00**

This charge includes a proportionate share of basic professional services of staff when we are not the primary licensed provider, use of facilities for service with visitation one hour prior.

**IMMEDIATE BURIAL****\$3,885.00 to \$8,880.00**

Our charge for an immediate burial, without any services, ceremonies or reviewal, includes removal and shelter of remains, local transportation to the cemetery, necessary authorizations and basic services of staff. These prices do not include embalming (if required), refrigeration (if required), any cemetery expenses or the cost of an outer burial container, which may be required.

**DIRECT CREMATION****\$3,220.00 to \$5,765.00**

This charge includes a proportionate share of basic services of funeral provider and staff for phone/online arrangements\*, transfer of remains to funeral establishment within a 25 mile radius, care of remains, refrigeration for up to 72 hours, local transportation to the crematory, crematory charges (additional charges for bariatric individuals or to witness the cremation) and temporary cremated remains container. This fee does not include embalming, other preparation of the body, visitation or funeral ceremonies, or other goods such as a cremation urn.

Minnesota law does not require you to purchase a casket for cremation. If you want to arrange a cremation, you can use a cremation container. A cremation container is a combustible, closed container that encases the body and can be made of materials like fiberboard or corrugated cardboard and into which a dead human body is placed prior to insertion into a cremation chamber for cremation. The containers we provide are made of compressed wood and corrugated cardboard and are the Meadowview, Prairieview, Theamation or Minimum Alternative Container.

FTC Funeral Rule does not require you to purchase a casket for cremation. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are Meadowview, Prairieview, Theamation or Minimum Alternative Container.
