Poster sessions are intended to provide a visual presentation of program or research findings by displaying graphs, photos, diagrams, and descriptive text. The presenter(s) must be available to answer questions during the designated poster sessions. Poster presentation submissions are due **January 16, 2026, 11:59pm (MDT)**.

The following information is required:

- ☐ Contact information (name, email, address, organization, job title, CHES/MCHES #, etc.)
- ☐ Short biographical sketch (200 words or less)
- ☐ Title of poster
- ☐ Abstract (300 words or less)
- ☐ Dates you are available to present (you will only present your poster on one day)
- ☐ Any product affiliation and conflict of interest
- ☐ A statement of accuracy on the information provided in the application

Please note:

- You must submit one application per abstract.
