
Dear Dr. Killion:

Thank you for referring your patient, Tyler Dusalt, for consultation regarding his cyanotic extremities.

Tyler is a 2-year old boy with a past medical history of esophagitis, diagnosed shortly after birth, also with a recent diagnosis of gastritis, and recent surgery for tonsillectamy and adenoidectomy, secondary to obstructive sleep appea. Tyler's parents noticed that since shortly after birth, when he has fits of crying, he also develops cyanosis of his hands and feet. The blue discoloration goes up to his wrist and up to his knees. They actually have one picture where they note it to have ascended to his nipple line. They also notice that this cyanosis occurs when he is having difficulty with his reflux. It seems to be painful to him at those times, and when his hands and feet are discolored, they seem swollen. He avoids wearing shoes when this occurs, and also complains of hand pain. These symptoms have not changed since his tonsillectomy and adenoidectomy. These symptoms seem to be occurring more frequently, and the parents also noticed that he has some crythema of his distal fingertips and the tips of his toes, which seem to be present almost all of the time.





## WEATHERFORD'S SOURCE OF INCOME IS VERY CONFUSING...

Weatherford's income has remained steady since he joined the Legislature. But he has continued to report his income in a confusing fashion.

His 2012 financial disclosure, made public Tuesday, continues to raise questions. In it, Weatherford reported a net worth of \$288,075 and total income of \$122,814. For the highest amount of income, \$52,000, Weatherford listed Breckenridge Enterprises/Diamond K Corp. He reported making an additional \$31,500 from Red Eagle Group, a company he said he formed in 2011 for tax purposes and because he wanted to be the owner of a small business. Red Eagle's income is paid entirely by Simpson Environmental Services, a Pasco County asbestos removal company that's owned by state Sen. Wilton Simpson, R-Trilby.

Given that Jamie Poole is a Ph.D. and CIH he had to know what was going on and absolutely had to know that this fraud was being perpetrated. However it may be hard to prove that. But you need to subpoena him as well as other test results from this "lab" and find out if this procedure for falsifying the results is a conspiracy or whatever lawyers call it.


