EXAMINATION WARRANT

I, Stephen W. Robertson, Commissioner of the Indiana Department of Insurance, pursuant to Indiana Code § 27-1-1-1, do hereby issue an Examination Warrant of Unique Insurance Company ("Unique"). Pursuant to Indiana Code § 27-1-3.1-1 *et seq.*, the Commissioner does hereby appoint Ingardus, LLC as examiner, to perform a targeted market conduct examination ("Examination") of the following company authorized to conduct the business of insurance in the State of Indiana as a non-resident property and casualty insurance company:

The Examination shall be to determine whether Unique:

- 1) Failed to properly process claims in violation of Indiana's Unfair Claims Settlement Practices Act found in Indiana Code § 27-4-1-4.5;
- 2) Failed to adequately and timely respond to complaints in violation of Indiana Code § 27-4-1-5.6;
- 3) Violated Indiana Code § 27-4-1-1 *et seq.*; or

4) Violated any other of the insurance laws in the State of Indiana.

Although the scope of this Examination is limited, the Commissioner reserves the right to expand this Examination.

As provided in Indiana Code § 27-1-3.1-9(d), the expenses of the Examination shall be borne by Unique. Additionally, Indiana Code § 27-1-3.1-9(b) states that Unique must provide access to its files and records. The Department interprets this statute to specifically include the preservation and retention of all paper files and electronically stored information that is related to this matter or within the scope period of the examination. Failure to take adequate steps to collect and preserve this information, including electronic data could result in additional administrative action.

The Examination review period is from July 1, 2010 through August 31, 2012. This Examination shall commence thirty (30) days after receipt of this Examination Warrant.
