Gishnock went on to say that "this program helps to celebrate what we have accomplished, better understand where we have room to improve, and help plan for a more sustainable future. As business owners, it's important that we consider the best use of our limited budget. We're in the process of aligning our budget to those key areas we've identified as potential areas for improvement."

Formecology LLC's sustainability progress includes several actions, such as purchasing renewable energy credits and focusing on energy efficiency in their facilities and equipment. The company also manages a large native prairie planting at the Formecology facility to enhance habitat diversity and utilizes a large rain garden to capture rooftop rainwater and infiltrate it onsite. They've also incorporated low-maintenance lawn grass into their landscape to reduce mowing, while constructing hardscape features with recycled concrete. Along with all of this onsite activity, Formecology also works closely with clients to enhance sustainability of their landscapes.

Applicants to the Green Masters Program are judged on a comprehensive range of sustainability issues, from energy to water use to educational outreach and governance. More than 125 Wisconsin businesses are participating in the program where the top twenty percent achieve the highest "Green Master" designation.
