

ORDINANCE 10-2026

**AN ORDINANCE WHICH MODIFIES THE SALARY SCHEDULE, WAGE SCALE,
AND HEALTH BENEFITS, FOR SPECIFIED POSITIONS OF THE VILLAGE OF
SHREVE AND DECLARING AN EMERGENCY**

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF SHREVE, COUNTY OF WAYNE, STATE OF OHIO TO PROMOTE THE GENERAL WELFARE AND THE SAFETY OF THE RESIDENTS OF THE VILLAGE:

SECTION 1. That the rate of compensation for the following Village Employees shall be effective as of March 16, 2026:

<u>Job Class</u>	<u>Hours yearly</u>	<u>Rate</u>
Chief of Police	2,288	\$30.00 - \$35.00 / hr
Police Lieutenant	2,288	\$28.00 - \$33.00 / hr
Police Sergeant – Full time	2,288	\$26.00 - \$31.00 / hr
Police Sergeant – Part time	Variable	\$22.00 - \$29.00 / hr
Police Officer – Full time	2,288	\$23.00 - \$28.00 /hr
Police Officer – Part time	Variable	\$19.00 - \$24.00 /hr
Village Administrator	2,080	\$75,000 - \$85,000 /annually
Utility Clerk – Full time	2,080	\$16.00 - \$22.00 / hr
Laborer	2,080	\$18.00 - \$25.00 / hr
Planning and Grant Administrator – Part time	Variable	\$45,000 / annually

SECTION 2. The Village of Shreve shall pay 100% of the health insurance premium for full time Village employees, with the Employee share being 0%.

SECTION 3. This Ordinance modifies the previous ordinance concerning the employee compensation for the job classes identified above. All job classes not included in this ordinance are not changed.


SECTION 4. This Ordinance is hereby declared to be an emergency measure necessary to the immediate preservation of the public peace, health, and safety of the Village of Shreve.
