A tax rate of \$0.100000 per \$100 valuation has been proposed by the governing body of Fort Bend Emergency Service District #6.

The no-new-revenue tax rate is the tax rate for the 2025 tax year that will raise the same amount of property tax revenue for Fort Bend Emergency Service District #6 from the same properties in both the 2024 tax year and the 2025 tax year.

The voter-approval rate is the highest tax rate that Fort Bend Emergency Service District #6 may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that Fort Bend Emergency Service District #6 is proposing to increase property taxes for the 2025 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON September 22, 2025 AT 6:30 pm AT the District's Station, 6400 Hwy 36 South, Rosenberg, Texas 77471.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, Fort Bend Emergency Service District #6 is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the governing body of Fort Bend Emergency Service District #6 at their offices or by attending the public hearing mentioned above.
