Notice is hereby given pursuant to Texas Government Code, Chapter 551, as amended, that the Board of Commissioners (the "Board" or "Commissioners") of **Fort Bend County Emergency Services District No. 6** will hold a regular public meeting on **Monday, June 22, 2026** at **6:30 p.m.**, at **Station No. 1, located at 6400 Hwy 36, Rosenberg, Texas 77471.**

The Board will consider and act upon the following matters:

1. Call meeting to order, join in the Pledge of Allegiance and acknowledge guests.
2. Public Comment – Each member of the public who desires to address the Board regarding an item not on the agenda may speak only one time and will be limited to *3 minutes* per speaker; responses to public comment about matters not on the agenda are limited by state law to a recitation of existing policy or a statement of factual information given in response to the inquiry. Any deliberation or decision by the Board shall be limited to a proposal to place the subject on the agenda of a future meeting.
3. Consent Agenda: The following items are considered routine by the District and will be enacted by one motion. No separate discussion will occur on the items unless a Commissioner or member of the public so requests, in which event the item will be removed from the general order of business and considered in its normal sequence on the agenda:
 - a. Prior Meeting(s) Minutes – May 18, 2026;
 - b. Treasurer Report, including authorize payment of bills; and
 - c. Quarterly Investment Report;
4. Schedule workshop meeting(s) regarding proposed Fiscal Year Ending December 31, 2027 Budget
5. Rosenberg Fire Department Report, including ISO update
6. Approve Agreement with Public Consulting Group (PCG) for strategic planning consulting services and take any necessary action regarding same
7. Review updated Local Sales and Use Tax Estimate Report prepared by HdL Companies and take any necessary action regarding the same
8. Discuss potential for Sales and Use Tax Election

These purposes include: receiving legal advice from its attorney(s) pursuant to §551.071, Texas Government Code; discussing real property matters pursuant to §551.072, Texas Government Code; discussing gifts and donations pursuant to §551.073, Texas Government Code; discussing personnel matters pursuant to §551.074, Texas Government Code; discussing security personnel or devices pursuant to §551.076, Texas Government Code; and discussing cybersecurity and critical infrastructure pursuant to §551.0761, Texas Government Code. If the Board decides to enter into Executive Session regarding any item on this agenda, the Presiding Officer will announce that an Executive Session will be held and will identify the item to be discussed and provision of the OMA that authorizes the closed or Executive Session.
