

NOTICE OF PUBLIC MEETING FORT BEND COUNTY EMERGENCY SERVICES DISTRICT NO. 6

Notice is hereby given pursuant to Texas Government Code, Chapter 551, as amended, that the Board of Commissioners (the "Board" or "Commissioners") of **Fort Bend County Emergency Services District No. 6** will hold a regular public meeting on **Monday, July 27, 2026** at **6:30 p.m.**, at **Station No. 1, located at 6400 Hwy 36, Rosenberg, Texas 77471.**

The Board will consider and act upon the following matters:

1. Call meeting to order, join in the Pledge of Allegiance and acknowledge guests.
2. Public Comment – Each member of the public who desires to address the Board regarding an item not on the agenda may speak only one time and will be limited to *3 minutes* per speaker; responses to public comment about matters not on the agenda are limited by state law to a recitation of existing policy or a statement of factual information given in response to the inquiry. Any deliberation or decision by the Board shall be limited to a proposal to place the subject on the agenda of a future meeting.
3. Consent Agenda: The following items are considered routine by the District and will be enacted by one motion. No separate discussion will occur on the items unless a Commissioner or member of the public so requests, in which event the item will be removed from the general order of business and considered in its normal sequence on the agenda:
 - a. Prior Meeting(s) Minutes – June 4, 2026 special and June 22, 2026 regular;
 - b. Treasurer Report, including authorize payment of bills;
 - c. Investment Report; and
 - d. Tax Assessor-Collector's Report and authorize writing off eligible delinquent tax accounts.
4. Adopt Order Declaring Property as Surplus or Salvage and Authorizing Sale or Disposal of Same.
5. Review District's Certified 2026 Taxable Value.
6. Rosenberg Fire Department Report, including ISO update.
7. Status of strategic planning process.
8. Status update regarding District logos/name on District equipment and take any necessary actions regarding same.
9. Review status of conveyance of proposed station property in The George development.
10. Review proposal(s) for necessary repairs to Station No. 1 and take any necessary actions on same.
11. Executive Session pursuant to Chapter 551, Texas Government Code, ("Open Meetings Act"), as necessary.
12. Confirm August 10, 2026 workshop and August 24, 2026 regular meetings.
13. Announcements by the Board and adjournment.

The Board is authorized by the Open Meetings Act ("OMA") to convene in closed or Executive Session for certain purposes. These purposes include: receiving legal advice from its attorney(s) pursuant to §551.071, Texas Government Code; discussing real property matters pursuant to §551.072, Texas Government Code; discussing gifts and donations pursuant to §551.073, Texas

Government Code; discussing personnel matters pursuant to §551.074, Texas Government Code; discussing security personnel or devices pursuant to §551.076, Texas Government Code; and discussing cybersecurity and critical infrastructure pursuant to §551.0761, Texas Government Code. If the Board decides to enter into Executive Session regarding any item on this agenda, the Presiding Officer will announce that an Executive Session will be held and will identify the item to be discussed and provision of the OMA that authorizes the closed or Executive Session.
