DPW Report –

John stated that the cameras at the DPW shop are not working as well as they have been. He has been having issues with the dumpster filling up immediately after it is emptied. This has occurred over the past 6 weeks. He is trying to get a good view of those who are doing this.

John asked whether the council had noticed that the parking bay lines were missing. He was unsure what had happened to them, but he would speak with the company and then come back to the council.

John reported that a few water meter installations remain needed; residents have not yet contacted the Village despite four notices.

John reported that at the Sewer Authority Board meeting earlier in the day, a discussion was held regarding adding an H2S/Odor Control Eliminator Program from Clearbrooke Technologies. The program would be applied twice monthly at two locations at a cost of \$1,369.26 per month, to be shared by Fulton Township and the Village of Perrinton.

Motion by Jason Blemaster, seconded by Jerilou Gallagher, to approve the H2S/Odor Control Eliminator Program at two locations with costs shared between Fulton Township and the Village of Perrinton.

John reported he had spoken with Brian Kipp regarding roof and siding repairs at the Fire Hall. A bid has not yet been received.
