Fintech-friendly vehicle

The proposal recommends an EAS under Law No. 6480/2020, highlighting streamlined incorporation, flexible shareholder arrangements, and governance suited to international fintech ventures.

AML registration path

PSAVs align with SEPRELAD and Resolution No. 314/2021 through formal registration, AML policies, internal risk controls, and supporting compliance documentation.

Commercial efficiency

Core institutions and laws referenced in the proposal

SEPRELAD

Paraguay's financial intelligence unit responsible for AML supervision and oversight.

Resolution No. 314/2021

Establishes compliance obligations for entities providing services involving virtual assets, including AML policies, internal controls, and formal PSAV registration.

Supporting legal base

The offer references Law No. 6480/2020 for the EAS structure and Law No. 6380/2019 for the accounting and tax framework.

The proposal centers on two linked workstreams: local corporate setup and regulatory / AML alignment.

Implementation structure

Corporate formation model designed for a compliant launch



Corporate structuring & formation

- Draft bylaws with a PSAV-specific corporate purpose
- Incorporate the EAS company
- Appoint an initial local nominee director
- Register with the Paraguayan tax authority (RUC)
- Complete supporting corporate registrations where required



Director transition & readiness

A local nominee director is appointed initially to facilitate the incorporation process. Once the company is established and operational requirements are completed, the directorship can be transferred to the client or to a director designated by the client.

Outcome: local vehicle + registration path + handover flexibility.

Registration scope

Registration as PSAV with SEPRELAD plus preparation preparation of the supporting compliance package.

AML / CFT framework

Design of manuals, controls, and procedures needed to needed to support registration and ongoing oversight.

Important execution items for foreign ownership and transfers



Foreign investor share transfers

A Power of Attorney is required to authorize a local representative in Paraguay to act on behalf of the investor.



Legalization requirement

The relevant documentation must be properly legalized in order to be valid under Paraguayan law.



Execution support

Preparation and legalization support can be handled within the corporate structuring services if required.

Build the documentation package early to avoid delays at transfer, onboarding, or post-incorporation handover stage.
