**Welcome to 2026.** Last year was a good year for our council. In 2025 we continued to do good works for the parish and community. Just a few of the highlights: we made Star Council for the eighth consecutive year; hosted a State Tour Stop; were in the top tier of sellers of charity raffle tickets; donated \$500 to support the installation of a Safe Haven Baby Box at Stow Fire Station No. 2. And, of course, held our most successful Fish Fry ever.

Looking forward, a couple of things stand out. Our council's Faith in Action Life team is close to getting a Safe Haven Baby Box installed in Springfield Township. Our team secured \$22,000 of funding from various foundation grants to pay for this installation. Just before Christmas, township trustees voted to approve the project. The contract between the township and the vendor, Safe Haven Baby Boxes has been signed and Monday, at our monthly meeting, we will vote to make our first donation to support the box installation. Then there is The Fish Fry. It is our primary fund raiser and accounts for about half of our council's funding. The committee is preparing for this year's series of dinners. The first one is on Feb. 20. That's not that far off. This is my first year involved in the planning of the event. It is a significant project and several Brothers and their families work to make our Fish Fries a success. The call for volunteers will be going out soon. Please lend a hand where you can. ## Here is the Last Chance to Order Council Blue Work Shirts Before Feb. 20 Fish Fry Season Opener

Dear Brother Knights, Trustee **Bob Eikenburg**, who coordinates our Council clothing, notes that this Sunday, Jan. 18, is the deadline for ordering one of our Council Blue Work Shirts (*See photo below*) in time for use during our upcoming Fish Fry season, which kicks off Friday, Feb. 20. Bob says: **"PLEASE NOTE THIS SPECIAL REQUIREMENT. YOU MUST PLACE AN ORDER FOR THESE WORK SHIRTS AS DESCRIBED AS FOLLOWS: DROP ME AN EMAIL, at [kaybobe@gmail.com](mailto:kaybobe@gmail.com), WITH YOUR SHIRT SIZE, IF YOU WANT A BLUE WORK SHIRT. PLEASE EMAIL ME YOUR ORDER BY THIS SUNDAY, JANUARY 18. THIS IS YOUR ONLY OPPORTUNITY TO GET ONE OF THESE SHIRTS BEFORE OUR FISH FRIES START ON FEB. 20. I CAN ONLY PLACE AN ORDER WHEN WE HAVE AT LEAST SIX SHIRTS TO ORDER.** At present, I have pending orders for only three Knights: **Rich Sprungle, Joe Campo and Ed Fetter.** **IF I HAVE AT LEAST SIX ORDERS, I WILL PLACE THE WORK ORDER WITH YOUNG'S THE NEXT DAY.** You will pay for your shirt when you get it from me. The cost of a work shirt goes down the more we purchase. For example, orders of 6-11 shirts cost \$24 per shirt. Orders from 12-23 cost \$16.50 per shirt. Orders of 24 or more cost only \$10 each. Let me know by phone or text at **(440) 759-2378** if you have any questions."



Our supplier for these products is Young's Embroidery and Silkscreen Printing. You should make contact directly with them yourself if you wish to purchase any item with the exception of the work T-Shirt. Young's has two locations you can choose from:

- 4299 Kent Road, #3 in Stow. Phone: (330) 686-8337 (they are located almost directly across the street from Panera's).
- 1245 Munroe Falls Ave., Cuyahoga Falls. Phone: (330) 922-5777 (they are just down the street from St. Eugene's Church).

When you call or go to Young's to place an order, identify yourself as a member of the Fr. Maruskin Council #10936, Knights of Columbus in Stow. This will allow the employee assisting you to locate the records in their computer system that contain all the specific information they need to ensure that you will receive the exact style and color of shirt. The Council goal is to have uniformity in color, style and quality. Here is an overview of the dress and polo shirts and shirts and cap:

1. **Button down dress shirt in "Rich Red" color.** Cost is \$44 plus tax, which includes the shirt and the Council logo embroidery. Minimum order is one.
2. **Traditional, short-sleeve polo shirt in "Rich Red" color.** Cost is \$29 plus tax, which includes the shirt and the Council logo embroidery. Minimum order is one.
3. **Red cap with Council logo.** This is the newest item. Young's has modified our Council logo (removing our council number) so that it fits on the cap. Young's has a big variety of baseball-type caps that you can choose from their catalogue. The most basic cap, which I have purchased, was \$23, including the cost of the embroidery.





## **Council Reestablishes Lines of Support to Embrace Clinic & Care Pregnancy Center**

We were pleased in early December to learn that the Barberton Embrace Clinic & Care Center has been restored to the list of approved Pregnancy Centers maintained by the Diocese of Cleveland. Changes in Embrace's website language in early 2024 designed to attract abortion-minded women to their services raised questions regarding their true support of Life. Following a full vetting, during which the Knights' support was suspended, the concerns were found to be groundless. The value of Embrace's pro-life work over many years is particularly important since they are one of two Pregnancy Centers supporting our Walking with Women in Need Ministry at Holy Family, notes **Pat Rynd**, Life Program Director.

Fortunately, the timing of the reinstatement came at a time when most needed for two important ongoing projects: Inclusion of copies of the New Testament Bibles with layettes hand-sewn for new born babies by Holy Family's Mary's Threads Ministry and Walmart Gift Cards for young mothers faced with unplanned needs for boots and shoes as winter strikes.

In December our Council approved two individual grants of \$500 each, to fund these Embrace projects. Also, each of these \$500 donations generated \$100 in additional funding, presented directly to Embrace from the Knights' Supreme Council Aid and Support After Pregnancy (ASAP) program.

With this most recent donation, Fr. Maruskin Council has given a total 860 Bibles to Embrace since 2021, including 197 included in the immediate past year of statistics. In addition to the layettes and Bibles, our Council also has presented new moms K of C prayer cards for consecrating their new families to the Holy Family of Jesus, Mary and Joseph. What a testimony to the success of Embraces work with new moms. Vivat Jesus!

## **Fr. Maruskin Council Invests in LIFE**

**Editor's Note:** *This newsletter article is adapted from a similar article written by Pat Rynd, Life Program Director, for the Holy Family parish bulletin.*

We paused this past week to somberly reflect on the January 22, 1973, Supreme Court Roe v Wade on abortion and the changes it brought to our Country and the State of Ohio. We rejoiced in an opportunity to bring a second Safe Haven Baby Box to the Summit County area.

While Safe Haven laws for the protection of newborns were established as early as 2001, it's only been in recent years that this has become a truly viable option. A birth mother and father can now safely, **and** anonymously, surrender their newborn (within 30 days) if they decide they are unable to care for their child. The baby is placed in a Safe Haven Baby Box at a participating local emergency services facility, where, after medical evaluation, it becomes the charge of the State's Foster Care System and is placed for adoption.

A Safe Haven Baby Box was just dedicated this past November by the City of Stow and is now fully operational at Stow Fire Station #2, 4199 Hudson Drive, Stow, Ohio 44224, just off the Steels Corners Road exit of northbound State Route 8.

Our Council's search for a partnering organization started in mid-2024, and three Summit County Foundations quickly provided financial support through coordinated grants. Discussions with a number of local fire departments has resulted in a signed contract with Safe Haven Baby Boxes, Inc. (SHBB) and Springfield Township. Our Council is scheduled to vote at our Jan. 19 General Membership meeting to provide Initial payment for acquisition and delivery of a leased SHBB.

SHBB, Inc. has grown significantly since its original founding some 10 years ago in northeast Indiana. The company now have some 400 units operational in 23 States of our Union, 107 which were blessed and dedicated in 2025 alone.

Seventy babies have been surrendered by courageous birth mothers, who chose what is best for their child. Fourteen surrenders took place in 2025, one of these in Lebanon, near Cincinnati, was the first in Ohio.

Hotline calls were received from over 1,800 women facing unplanned pregnancies this past year. Please join us in thanking the Holy Spirit for showing us God's presence in guiding this project to reality. Vivat Jesus!
