

The goods and services shown below are those that we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

BASIC SERVICES OF THE FUNERAL DIRECTOR AND STAFF **\$2,375**

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.

- ◆ Personnel available 24 hours a day, 365 days a year to respond to initial call
- ◆ Arrangement conference
- ◆ Coordinating service plans with cemetery, crematory, and/or other parties involved
- ◆ Clerical assistance in completion of various forms and permits associated with a funeral
- ◆ Also covers overhead, including facility maintenance, equipment and inventory costs, insurance and administrative expenses and governmental compliance

EMBALMING* **\$995**

Embalming is a chemical process which provides temporary preservation of the body and eliminates certain health hazards. A person licensed by this state must complete this procedure. Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

According to 37.116.103 Administrative Rules of Montana, a body "en route more than 8 hours, or if the termination of common carrier, transport occurs more than 36 hours after the time of death, the body must be either embalmed or refrigerated at 35 degrees F or colder" or "when being transported by a private conveyor and the body will not reach its destination within 48 hours after the time of death, must be either embalmed or refrigerated at 35 degrees F or colder."

All accounts are expected to be paid in full at the time services are provided.

EARLY PAYMENT DISCOUNT

For payment in full of the total funeral expenses by debit card, check or cash within seven days from the date of the signed contract, we will allow a discount on the Itemization of Services or Service Offerings price. Items such as caskets/alternative containers, vaults, merchandise, and cash advances are not eligible for this discount.

INSURANCE ASSIGNMENT

An assignment of valid life insurance policy can be made to Schnider or O'Connor Funeral Home up to the total amount of funeral expenses. If we are to be paid through insurance, we will need the policy, and all of the beneficiaries of the insurance policy must sign the insurance assignment.

CREDIT CARD PAYMENT AND PROCESSING FEE

We accept credit/debit card payments for all or part of the mortuary charges and cash advances. Due to the rising costs of credit card companies, all credit card payments are subject to a 3.0% processing fee. The early payment discount does not apply if paying with a credit card.

OTHER

Financial arrangements other than the above must be discussed and agreed upon prior to the conclusion of the funeral arrangements.

INFANT/CHILD SERVICES

Service charges for a child will be discounted according to the age of the child. Caskets, outer burial containers, cemetery expenses and honorariums will be in addition to the service charge.
