2025 Annual Achievements

Mission Statement

The South King County Mobility Coalition (SKCMC) continuously identifies, and initiates coordinated, creative, sustainable ways to assist individuals, including older adults, youth, persons with disabilities, limited English speakers, Veterans, and low-income individuals in South King County reach their potential by increasing their transportation options.

Coalition Meetings

- One way SKCMC achieves its mission is by convening coalition meetings to discuss topics and initiatives to improve the mobility landscape in South King County. We convened 6 virtual coalition meetings with an average of 16 attendees. Topics discussed included:
 - o King County Metro's South Link Connections Mobility Project
 - SKCMC & NKCMC's Cross-County Transportation Guides
 - King County Metro Service Changes
 - Discussions of Coalition Workplans
 - King County Metro RapidRide I-Line Project
 - o The King County Mobility Coalition's Rural Transportation Advocacy Project
 - Sound Transit Service Changes
- Additionally, SKCMC meetings had attendance from 19 unique organizations, 11 of which are active
 and attended at least 1/3 of the coalition meetings this year. Active SKCMC coalition partners include,
 but are not limited to: SeaMar, Catholic Community Services, King County Metro, Pierce County
 Coordinated Transportation Coalition, City of SeaTac, City of Auburn, City of Tukwila, and Molina
 Healthcare.

Member Engagement and Outreach

- SKCMC partners received weekly updates and announcement emails regarding transportation news, region-specific topics, and resources. These emails raise awareness about the mobility landscape in South King County and were sent to over 128 partners, 19 of which were new partners in 2024.
- The Community Transportation Navigators (CTN), specifically the cultural CTN cohorts, continued to be a great support in outreach goals and the missions of South King County Mobility Coalition in 2025.
- Participated in quarterly Peirce County Coordinated Transportation Coalition meetings to share and gather information on transportation services in Pierce and South King Counties, fostering cross-county collaboration and innovation.

MOBILITY COALITION

- Formed new partnerships with World Relief, Evergreen Goodwill Job Training & Education Center, Southeast Seattle Senior Center, Vine Maple Place, SeaTac Community Court, King County Library Systems, and King County Promotores Network. The mobility work in South King County has benefited from the distinct perspectives and insights offered by each of these new partnerships.
- Completed 56 in-person Getting Around Puget Sound (GAPS) outreach events, 15 in-person Public Transit Orientation (PTO), and 4 virtual and in-person Travel Ambassador Trainings (TA). Out of the three different education and outreach programs, 1,182 clients were served.

Projects and Partnerships

- SKCMC staff and the CTNs supported community outreach and mobility education projects with the
 city of Tukwila's South King County Trips program. This program encourages community members to
 be more mobile, healthy, and safe by offering incentives in addition to a wide range of information and
 resources. One incentive that the program offers is an ORCA Card reward for completing a
 transportation survey that asks about the clients' transit habits and commuting. Through this
 partnership we conducted outreach to over 300 clients.
- In partnership with North King County Mobility Coalition (NKCMC), SKCMC completed a joint project to
 create cross-county transportation resource guides for North and South King County. Each subregion
 developed a detailed digital guide and a high-level physical guide to share with partners and clients.
 Designed to raise awareness of services supporting cross-border travel, the physical guide has been
 especially valuable at outreach events as accessible, easy-to-use, resources.
- In partnership with the Snoqualmie Valley Mobility Coalition (SVMC) and King County Mobility Coalition (KCMC), SKCMC has begun planning a Rural Transportation Advocacy workshop in rural South King County to take place in the summer of 2026.
- In collaboration with King and Pierce County-based transportation providers, SKCMC has built strong
 relationships with local transportation agencies and internal staff to provide SKCMC partners with
 accurate and updated services and changes. These service updates and changes were shared with
 SKCMC partners regularly through weekly announcements and in coalition meetings.
- In October of 2025, SKCMC co-hosted Sound Transit's South-end Open House with Mother Africa Services to help educate the community on service changes around the Federal Way Link Extension opening and encourage people to take Sound Transit's Service Changes Survey.
