# Thank God for a New Start

I'm 27 years old, and I was born on the south side of Little Rock, AR. My mother was the sole provider of our family of six. Growing up without a father made life tough, so my brothers and I were pressured to become the men of the house while living in a gang, drug, and poverty infested community. I wanted a better life; however, my role mod-



els became the drug dealers and gang bangers. I was first incarcerated at the age 14 for possession of a firearm, and I served only two weeks before I was released. The next time I was charged with simultaneous possession of drugs and firearms and received 4 years in ADC but served 8 months. Upon my release I went back to a life of crime and adding aggravated robbery, aggravated assault, and numerous other charges to my rap sheet. These new charges lead to me serving a 30 year sentence at the age of 19. While serving my sentence, I met a prisoner who expressed that PTF would be the perfect program, and he assisted me in filling out the application. Within weeks, I was transferred to the Wrightsville

Unit where PTF taught me six core values that would help set the foundation of my life and add much needed structure. Going through PTF prepared me to face the temptations of the world. I was released December 6, 2021, and secured employment, and reliable transportation. Three months later I was accepted into a trucking school called, Diesel Driving Academy. PTF assisted me in my enrollment and supported me through the duration of my schooling. After roughly four weeks of completing Diesel Driving Academy for my CDL, I was hired by Tyson Foods as a Truck Driver. I am grateful for the support I have been given by PTF. I would like to thank Scott McLean and all his staff for giving me a chance to be the best me.
