Before arriving through the back door of Pathway to Freedom, my life was a complete wreck. I had been in and out of state custody, juvenile detention centers, jails, and prisons since I was I4. I was involved in every element of street and criminal life imaginable; drugs, gangs, theft, violence, and my past reflect it all. Although I grew up in a relatively good home in Camden, Arkansas, I have been estranged from my parents and entire family since I was I4. My defiance, disrespect, and the many years I spent in prison drove us apart. I served six years, stayed free for only four months, returned for another 10 years, and now another eight years. This means I literally spent half my life incarcerated. What went wrong in my life? How do I change it? For nearly 30 years, that

was who I was and those were the questions I had to ask myself since returning to prison this time.

After sharing parts of my story with other inmates, I was strongly encouraged to contact PTF and see if I could join their program. Since coming here, I've not only found answers to those questions but also uncovered and addressed deep-rooted internal issues that I probably never would have discovered or confronted without this program and the supportive environment it creates. I've made tremendous progress in my life, improving my relationships with my family and my son. Most importantly, PTF has given me the space and opportunity to experience the love and obedience of Christ and all the joy, peace, and victory that come with it. Before baptism, I recognized the stark contrast between my proclaimed faith and my actual life. While at PTF, the Lord began stirring my heart, convicting me not only about my past but also about the sins still dwelling in my heart. In that moment, I cried out to God for rescue. I resolved, not only mentally, but in my heart that I no longer wanted to live the life I had. I longed not for a seasonal change, but for an eternal, lasting transformation achievable only through the blood of Jesus Christ. From there, I immersed myself in the Word, studying, praying, and learned about an upcoming baptism.

I wanted to renounce my identity as a gang member, a convict, and all the chains that had bound me. So, on April 3, 2025, I seized that opportunity. Many doubt the supernatural power of baptism itself, but I disagree. When I came out of the water, I truly felt changed. A surge of rejuvenation and redirection washed over me. Since then, I've experienced profound peace, joy, and most of all, freedom. It's as if I'm on a natural high, without anything illegal. I'm deeply grateful to Mr. Scott and the entire PTF community for fostering such an environment and providing this opportunity.
