GENERAL PRICE LIST

These prices are effective as of October 1, 2025, but are subject to change without notice.

Simple Direct Cremation Package: \$995

This package includes the basic services of the funeral director and staff, **transfer of the body from the place of death (within 20 miles of Shoreline Cremation Society) to our refrigerated holding facility and cremation facility, preparation of the deceased for cremation with positive identification, filing of death certificate with County, minimum cardboard cremation container, the actual cremation process, and the basic durable plastic urn. Package also includes one (1) burial permit. Cremations are scheduled for 14 days (about 2 weeks) after payment is collected.

****A SECOND ATTENDANT FOR TRANSFER COULD BE AN ADDITIONAL COST DEPENDING UPON THE SITUATION OR REQUIREMENTS. ADDITIONAL FEES FOR TRANSPORTATION BETWEEN THE OFF HOURS OF 5:30PM-7:30AM, RESIDENCE REMOVALS, AND/OR FOR DECEDENTS WEIGHING MORE THAN 250LBS WILL APPLY. ****

If you elect NOT to purchase the package above, but prefer to pay full retail as indicated by the prices below, then these ranges apply:

Direct Cremation \$870 - \$1735

Our full retail charge for a direct cremation (without ceremony) includes basic services of funeral director and staff; a proportionate share of overhead costs; removal of remains; refrigeration; transportation to crematory; necessary authorizations; and cremation of decedent weighing up to 250lbs.

- A. Direct Cremation with Container Provided by Purchaser \$870
- B. Direct Cremation with Alternative Container \$995
- C. Direct Cremation for Decedent Weighing 251 lbs. – 325 lbs. w/ Air Tray \$1735

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering.) The containers we provide are cardboard. Shoreline Cremation Society does not offer caskets for sale or rental.

Direct Alkaline Hydrolysis Package: \$4,600

This package includes the basic services of the funeral director and staff, **transfer of the body from the place of death (within 20 miles of Shoreline Cremation Society) to our refrigerated holding facility and to the Alkaline Hydrolysis facility in Palm Springs, CA, preparation of the deceased for hydrolysis with positive identification, filing of death certificate with County, no minimum cardboard cremation container is needed, the alkaline hydrolysis process, and the basic durable plastic urn. Package also includes one (1) burial permit. Cremations are scheduled after payment is collected and at the availability of the Palm Springs facility.

Itemized Selections

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

Full List of Individual Services

Basic Services of the Funeral Director and Staff \$ 750.00

This charge for our basic services and overhead will be added to the total cost of the cremation rearmaments you select. This fee is already included in our charges for direct cremations. This charge includes but is not limited to, availability of staff 24-hours a day, staff and facilities to respond to initial request for services, consultation with responsible party to determine services desired, coordinating service plans with cemetery, crematory and/or other parties involved in final disposition of the deceased, filing local death certificate, obtaining local disposition permits with the health department.
