- 6. ACTION ITEMS (All motions must be on agenda)
 - a. Replacement for Max Easton's position on the board Frederiksen requested nominations to replace Max Easton's position. Gabehart nominated Ken Mack. Halliday nominated Lorna Surman. Mack was not present. Lorna Surman explained that she would like to be on the board, she has been a member her whole life she likes to pontoon, fish and camp with her kids. Ballots were passed out and counted. Surman had 7 and Mack had 3 votes.

c. Electric Bikes speeding – Mallaney advised that he was walking, and an electric bicycle went by at a fast speed. Frederiksen stated that this needs to be addressed and has her name. Discussion took place that anything with a motor needs to follow the speed limit and if not should be written up. It was determined to refer any issues to the manager to ensure electric bikes/scooters are following the speed limits. A recommendation was made to post this on the website and Facebook page and at gate and include peddle bikes regarding speeding.

7. COMMITTEE REPORTS (INCLUDES COMMITTEE SPECIFIC MOTIONS)

- a. Area/Farming/CRP –Frederiksen, Obert, Trotter- Frederiksen stated that the crops should be coming out soon, Uerkwitz will put a lock on the gate in the front and give a key to John Trotter. Mallaney questioned the status on the guard rails on Whiteite Rd. Frederiksen stated that we will support the effort to install them and that the grant would go through the township road commissioner. He explained that Felix township meeting is tomorrow at 6p. Frederiksen questioned Uerkwitz about the trails and he reported that he worked on it today and will do more tomorrow, since he got stuck with the backhoe. Uerkwitz continued to report that he mowed roach hole and the snowmobile trails.
- **b. Beach** Vota, Halliday, Brainard Beach is closed Halliday reported it was a great season, and the Sunroom was rented 17 times, and we at least broke even. Mallaney suggested a split rail fence by the playground and by the concession stand. Discussion continued and referred to the beach committee.
- c. Boating Bolker, Vota, Stiles Nothing
- **d.** Budget Bolker, Vota, Frederiksen Bolker will start working the number to determine what projects we can handle for next year.
- e. By Laws Vota, Frederiksen, Halliday Nothing
- **f.** Camping Bolker, Gabehart, Mallaney, Obert Bolker called Elliot Electric to get a survey of the old campground facilities to determine what should be done. Discussion continued on previous bid from Clennon and if we can get another engineer to determine the needs. Frederiksen stated that we need to determine if the current feed will support what we want to do. Obert requested that we need to look at the trees that hit the campers. Uerkwitz was requested to care for or see if we need to hire someone.
- **g. Docks** Jacovec, Trotter Stiles asked if docks can have 2 pontoons boats at a dock? Jacovic advised that there is not a bylaws that restricts it but it is common curtesy to give the other dock space for their boats.
- **h. Equipment** –Jacovec, Mallaney, Trotter Mallaney reported one lawn mower need repair. Uerkwitz reported that the black truck is gone. Discussion continued.

- i. Fishing Gabehart, Obert, Stiles, Brainard– Gabehart reported that he sprayed the weeds at Delaby and ordered more spray to clean the ramps. Also, 18 bass were caught from there.
- i. Gates and Security Noffsinger reported that he is looking into getting the gate guards safety vests, and installing speed bumps, additional stop signs and concrete pylons or curb to keep them safer. Discussion continued. Vota explained that the cameras at the gate only store data for about 2 weeks, if there are any incidents.
- **k.** Hunting Frederiksen, Mallaney, Brainard, Stiles Frederiksen reported deer season is coming up 10/1. Mallanev reported they had their meeting and have one new member, Josh, covered rules and regulations. The duck season starts 10/25.
- **l.** Safety Noffsinger See Gates and Security.
- m. Seasonal Activities/winter sports Halliday Gabehart, Jacovec Trotter Gabhart reported that the mushrooms are out, sheep heads, oyster and others, but watch for ticks and jiggers.

Halliday is promoting the Rib Cook Off on 10/5, there will be a max of 25 people participants and Gabehart asked that tasters bring a side dish.

The Spooky Sunday Funday will be 10/12. They expect a big crowd since it is a long weekend. Discussion continued on the set up for the pumpkin carving contest. Gabehart will cook hotdogs. Frederiksen will do the judging. Uerkwitz reported that there were 1050 that attended the Vet picnic Gabehart.

- **8. Manager's Report Uerkwitz** Uerkwitz reported that the snowmobile trails were mowed, the railroad ties were cut up, he fixed the swing, took out the small rafts at the beach, removed trees and mowed in area 8, mowed the roach hole, sold the black truck to Broadway salvage and drained and blew out the sprinklers pump at the swim beach. He reported that the veterans picnic went well. Vota asked for an update on the light poles. Uerkwitz advised that there is no light at the north end of Broadway at the entrance of the club, it is just a sensor. The light pole at the north end of the beach does not have any power to it. After a discussion it was determine that it used to come from the house but would need to be trenched in now. Uerkwitz stated that air conditioners were still working in the concession stand and we need to find out when the food will be removed. Vota will contact Figuero.
- 9. Operations Manager's Report Uzzardo Uzzardo reported that the beach is closed, and it went well. Lifeguards did a fantastic job. Just had a little hiccup with the scheduling on Labor Day Weekend. We need to determine if we want to hire non members for next year. She is working on reconciling the key cards, speedboat and dock permits. She asked everyone to get a wish list ready so we can plan for next year's budget.
