## WHAT'S COOKING



### Honey-Lime Fruit Salad

#### Ingredients:

- ✓ 1 cup strawberries, halved
- ✓ 1 cup blueberries
- ✓ 1 cup pineapple chunks
- ✓ 1 cup green grapes, halved
- ✓ 1 cup watermelon, cubed
- ✓ Juice of 1 lime

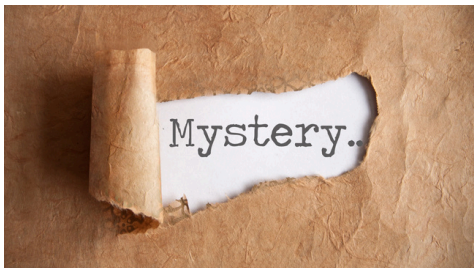
