4059 MINIMUM DISTANCE FROM PUBLIC BUILDINGS FOR SALE OF ALCOHOLIC BEVERAGES

Motion by Commissioner Posey, seconded by Commissioner Wranitzky, the Court adopted the following order.

**ORDER OF COMMISSIONERS COURT ESTABLISHING THE MINIMUM DISTANCE FROM A
CHURCH, A PUBLIC SCHOOL, OR A HOSPITAL FOR THE SALE OF ALCOHOLIC BEVERAGES,
AND LEVYING COUNTY LICENSE FEE**

On this the 13th day of June, 1970, the Commissioners' Court of Hays County, Texas, convened in regular session at the Courthouse in the City of San Marcos, Texas, with the following members present, to wit: Max Smith, County Judge; Eugene Posey, Precinct No. 1; B. R. Wranitzky, Precinct No. 2; Jack Oldham, Precinct No. 3; and Leonard C. McCarty, Precinct No. 4, and, among other proceeds had, the following order passed:

WHEREAS, the Commissioners' Court of Hays County, Texas has considered the matter and deemed it appropriate to enter an order establishing the minimum distance from a church, a public school, or a hospital for the sale of alcoholic beverages, and to levy a license fee; now, therefore,

BE IT ORDERED, ADJUDGED AND DECREED by the Commissioners' Court of Hays County, Texas, that no person shall sell, or engage in the business of selling, any alcoholic beverages where the place of business is located in Hays County, Texas, in the territory thereof outside incorporated cities and towns where any such place of business is located within three hundred (300) feet of any church, public school, or public hospital, the measurements to be along the property line of the street fronts and from front door to front door and in a direct line across street intersections where they occur.

IT IF FURTHER, ADJUDGED AND DECREED by the Commissioners' Court of Hays County, Texas, that there is hereby levied and there shall be collected from every person, firm, association, or corporation licensed under the Texas Liquor Control Act a license fee equal to one half (1/2) of the State fee, except as to temporary licenses, said tax to be paid annually in advance, except as otherwise provided by State Law.

The above order being read, it was moved and seconded that same pass. Therefore, the question being called for, the following members of the Court voted aye and none voted no.
