Judge Becerra clarified the intent of this item is to support the City of San Marcos with the purchase of this property from the Independent School District to become a cultural center where this property is not to be donated or operated by Centro Cultural Hispano de San Marcos. Commissioner Ingalsbe stated the property is important due to it being in a historic Hispanic neighborhood and any new developments such as apartment complexes would cause potential displacement and alter community character. Vickie Dorsett, Budget Officer, stated the commitment from the court is about half a million dollars for the project. Dorsett stated this could be funded out of the Undesignated Miscellaneous Capital Improvement Funds that are budgeted for FY2025 if the project is secured by an agreement this fiscal year. Otherwise, the project funds would come out of 3.5 million for undesignated projects in FY26. Dorsett asked for clarification if there would be action to take today or if there would be an agreement coming back to court at a later date. Commissioner Cohen stated her understanding of preserving culture within the community and supports moving forward with the property. Commissioner Hammer asked if the ISD would be willing to work a deal with the county and asked who would be in charge of maintaining the property. Judge Becerra gave some possible design ideas for the property. Commissioner Smith asked what the size of the property was and stated his concerns about the future sustainability of any structure placed on the property.

Judge Becerra opened the Budget Workshop at 11:00 a.m. Pastor Jeff Thompson made a public comment stating more money is needed for a public defender's office, housing and social services. Eric Martinez, Executive Director with Mano Amiga, made a public comment in favor of the court to fully support funds for Capital Idea, the Public Defenders Office, Hays County Health Department and other non-profit entities. Alyssa Garza, Mano Amiga, made a public comment regarding a low score the county received from a pilot budget equity assessment. Vickie Dorsett, Budget Officer, expressed her appreciation for the feedback on the budget and stated that as a county we have 38 other special funds including the ARPA fund. Out of the \$44 million received in ARPA funds, at least \$34 million was put back into internal programs for judicial services or paid out to social service agencies within the community. Judge Becerra stated \$10 million was spent on radios for emergency responders and the elections building. Dorsett stated she completed a comparison of FY23 to FY26 and pulling in all resources, the court has increased the Judicial Services budget by 72% in the past four years. Commissioner Cohen stated she hopes to develop a strategic plan around criminal justice reform in all areas. Dorsett stated that she set aside funds to be allocated to a Criminal Justice Division director in hopes of moving these initiatives forward. Commissioner Hammer stated there is always room for improvement, but there are finite resources. She mentioned the upcoming workshop meetings and the importance of sharing this information with the public using the county's social media outlets. Commissioner Smith stated there has been a landmark difference in where budget dollars go over the last several years. Dorsett stated that there will be a Budget workshop on August 12, 2025, and August 19, 2025, at 11 am followed by a final hearing at 1pm on August 19, 2025 to vote on a proposed budget and tax rate. Commissioner Cohen asked for the budget to be posted in a more timely manner and an explanation of the process to possibly improve it. Cyrus Gray, made a public comment urging the court to consider the voices of the community and properly place funds in the right resources. Myles Martin, made a public comment about investing in social services for Hays County, including a re-entry facility. Judge Becerra closed the Budget Workshop at 11:32 a.m.

Judge Becerra read the Sheriff's update of the inmate population. Current maximum jail capacity is 410 inmates. Jail Standards recommends holdings 10% open, lowering current capacity to 368 inmates. The jail's daily average was 566 for the week of July 27, 2025, with a peak of 578 inmates on August 2, 2025. The estimated cost for outsourcing inmates the week was \$134,045. The average number of outsourced males is 201 and females is 0. This week's inmates were housing in the following counties: Haskell. The number of "paper-ready" inmates who are now wardens of the state is 47.
