Judge Becerra called the meeting to order. Judge Becerra led the court in the Pledge of Allegiance to the United States and Texas flags.

# **PUBLIC COMMENTS**

Nathan Pino made a public comment against flock cameras. Shannon Fitzpatrick made a public comment in support of an increase for the Public Defender's Office (PDO) budget. Eric Martinez with Mano Amiga made a public comment that the court should take funding from Flock cameras and use it elsewhere. Amy Kamp made a public comment asking the court to work together to end ties with Flock cameras and fully fund the PDO. Natasha Eve made a public comment against Flock cameras. Tristan Mayberry signed up for public comment but was not present. Myles Martin with Mano Amiga made a public comment stating he was affected by systems like the Flock cameras and spoke against implementation. Kama Davis made a public comment thanking the court for their service and spoke against the use of Flock cameras. Cyrus Gray with Mano Amiga made a public comment against Flock cameras stating that surveillance does not address the root reasons for crime. Devonte Amerson with Mano Amiga made a public comment against the expansion of the police budget. Sam Benavides made a public comment urging the court to vote against the expansion of Flock license plate readers. Briana Ramirez-Vargas, Deputy Clerk, read emailed public comments from the following individuals: Chase Norris emailed a public comment thanking the court for considering the purchase of land next to El Centro in San Marcos for preservation as a public plaza. Sharri Boyett emailed a public comment asking the court to please act now on the contract for an animal shelter in the area. Alonna Beatty emailed a public comment in support of an environmentally sensitive area in the Edwards aquifer that should be preserved.

Presentation by the San Marcos Area Chamber of Commerce regarding the use of the American Rescue Plan Act (ARPA) funds for Education & Talent Pipeline Development Programs with San Marcos Consolidated Independent School District.

Page Michel, President of San Marcos Area Chamber of Commerce, thanked the court and provided a detailed annual report.

Presentation by the Hays County Fire Marshal, Steve Seddig, regarding an annual update on his office.



Steve Seddig, Hays County Fire Marshal, provided a PowerPoint presentation update on the office, outlining what the office does and the funds needed. He described the area's growth and mentioned that with current staffing, the department cannot handle annual inspection and unpermitted development enforcement. They have three full-time workers and are requesting an additional two positions. Commissioner Hammer mentioned she brought this up to educate the public and the court on the structure of the department and what they do. Commissioner Smith spoke about a third-party review process increasing efficiency. Judge Becerra mentioned they could enable the Fire Marshal to access the departmental timesheets. Commissioner Cohen acknowledged how busy the department is and said strengthening efficiency will be part of the budget process. Commissioner Ingalsbe thanked the department for what they do. Vickie Dorsett, Budget Officer, explained that the current budget allows for no additional staffing.

Orlando Gallegos, engineer with TxDOT, introduced himself and stated he is looking forward to a great relationship with the county. The court welcomed the new area engineer.

Gregg Cox, Criminal First Assistant District Attorney, stated this contract will allow for a storage median for the Txshare Prosecutor program. He stated most law enforcement agencies use Axon as a support system to upload body and dash camera footage. Cox stated two benefits of this agreement will allow all information from the Law Enforcement system to be pushed into the Justice system as well as unlimited storage. Stephanie Hunt, Purchasing Agent, stated this is a competitively priced contract that Txshare gives us a discovery platform where the county can share with those requesting. Cox stated Axon Justice and Txshare work together already, thereby streamlining the process and fulfilling the county's legal obligations. He stated the videos will be able to be transcribed automatically without using court reporters, saving the county money that equates to three additional personnel.

Clerk's Note: Judge Becerra spoke on the items that were tabled and stated emailed comments would be read next week, and no additional action will be required.

11:00 a.m. - Budget Workshop regarding the Fiscal Year 2026 budget. Possible action may follow.

Alyssa Garza made a public comment in support of fully funding the Public Defenders Office. Juan Miguel Arredondo made a public comment asking the court to fully fund the Public Defenders Office budget as proposed. Nataly Avendano, Mano Amiga, made a public comment asking for \$10 million or more for the Public Defenders Office. Cyrus Gray made a public comment urging the court to invest in systems and institutions that lift people up not ones that tear trust down. Devonte Amerson made a public comment asking the court to shift money to intervention and tools to keep people out of the criminal justice system. Eric Martinez, Mano Amiga, made a public comment supporting Capitol IDEA at the \$100,000 level and urged the court to fully fund the Hays County Public Defender's office. Judge Becerra asked Vickie Dorsett, Budget Officer, for more information on the amounts of money used to pursue someone vs. defending them. Dorsett explained that pretrial, indigent defense, and magistrate would all need to be weighed. Judge Becerra stated the request is a good one, but is not sure whether it can be done in such a short amount of time. Commissioner Ingalsbe asked whether the relationship with Neighborhood Defender Services (NDS) would be reestablished, to which Dorsett responded the contracts were not extended and if continued the county will absorb the cost. Commissioner Cohen asked what the tax rate increase would need to be to fully fund the Public Defenders Office requested budget. Dorsett explained the requested \$10 million would mean an additional 2-cent increase on top of the requested increase. The court agreed on completely supporting the Public Defender's Office and wanting people to have due process, discussed the need for a plan for these services and moving forward with the tax rate. Commissioner Hammer stated the court wants to invest in our community members, but there is a finite amount to spend and the jump in budget requests from \$2 million to \$10 million is steep. Commissioner Smith stated the budget proposal multiplied the contract by 5 without any specifics, but he wholly supports the PDO. The court discussed fringe benefit costs as well as departmental oversight and accountability. Stephanie Hunt, Purchasing Agent, stated that Hays County is only permitted to increase contracts by 25% and only \$2.1 million is available with the current contract, therefore a new contract would have to be in place. Jeff Thompson, Board Treasurer of Central Texas Interfaith, expressed appreciation for past support and asked for increased financial support for the program. Alyssia Palacios-Woods, Executive Director of Capital IDEA, gave a PowerPoint presentation on the approach and model of the organization and requested increased support. Jennifer Escobar, Tax Assessor-Collector, requested to regrade two positions and make compensation corrections. Escobar identified the money will come from leftover software funds. Theresa Cruz, Assistant Tax Assessor-Collector, spoke on the continuous needs of the Tax Office and stated the need for additional staff will always be a priority.



David Peterson, Constable Precinct 1, requested one Deputy Constable, Civil; LE equipment and vehicle; regrade Justice Administrator from a 115 to 118; Tahoes or F-150 instead of Durangos; bulletproof vests, replacement TCIC computer, rugged computer for motor officer, additional equipment for 2023 Tahoes, increase Lidar and Stalker radar, two Deputy Constables, Bailiff; LE equipment and vehicles needs and an increase to the training budget. Mike Varela, Deputy Constable Precinct 1, emphasized the need importance of the requested items. Jimmy Alan Hall, County Court at Law No 1, spoke on the need for two additional deputies to assist with bailiff duties per recommendation from the Office of Court Administration. Dr. Elaine Cardenas, Hays County Clerk, requested a regrade and retitle of all positions within the County Clerks Office. Cardenas identified a large portion of the request will be funded by the records management fund. Vickie Dorsett, Budget officer, stated the inital amounts were more than what it would actually cost to fund this change. Daphne Tenorio, Hays County Treasurer, requested a Financial Analyst II regrade to III Step 3; New Financial Analyst I; and an Elected Official Increase. No action taken.

**4 2 1 2 6** Executive Session pursuant to Sections 551.071 and 551.074 of the Texas Government Code: consultation with counsel and deliberation regarding the employment, evaluation, reassignment, duties, discipline, or dismissal of the Transportation Director. Possible discussion and/or action may follow in open court.

Commissioner Smith stated that Jennifer Moczygemba, Transportation Director, was placed on a Personal Improvement Plan (PIP) 60 days ago and at that time, the court determined to move forward with a 2nd PIP which ended last week. Erik Granjeno, Human Resources Director, spoke about the survey that was distributed to the roads department staff post the PIP, and reviewed some comments provided from the survey. Granjeno also provided goals that were to have been achieved after the extended PIP. The court expressed exhaustion with the process and shared a consensus of moving forward with a change of leadership in the Transportation Department. Granjeno shared that both current and former employees had raised concerns, primarily focused on individual expectations rather than broader issues. Judge Becerra asked whether Granjeno had specific concerns with this particular improvement plan or with the overall process. Granjeno stated that typically, there is a period of mediation or relationship-building, which was not pursued in this case. He noted that an opportunity was missed for Moczygemba to meet with her team and engage in meaningful conversations. Granjeno confirmed that the initial PIP requirements were met, and stated the expectations were fulfilled. There was further discussion about whether the process followed standard human resource practices. Judge Becerra asked if Granjeno recommended termination to which Granjeno responded that he did not and emphasized the need for a more holistic approach to discipline where one based on measurable departmental goals and input from subordinates. He noted that the current plan was heavily focused on feedback from subordinates rather than objective performance metrics. Commissioner Cohen pointed out that concerns arose within 30 days of Moczygemba's employment and a PIP was initiated shortly thereafter. Commissioner Hammer added that criticisms of Moczygemba came from sources beyond just her subordinates. Jennifer Moczygemba, Director of Transportation, stated that this was the first time she had seen the survey results or the related comments and noted that she was not given an opportunity to discuss or address these concerns in conversation. Moczygemba stated despite the challenges, she had several accomplishments, including advancing bond projects and successfully hiring and retaining staff. She acknowledged the difficulty in succeeding a longserving director and emphasized her leadership style, which supports staff autonomy while maintaining departmental oversight. She also stated that while employee feedback is valuable, it is ultimately the director's responsibility to act in the department's best interest. The court acknowledged that some departmental goals had not been met and that certain aspects of management style cannot always be taught.



Moczygemba reiterated that without access to the specific comments or feedback, it was difficult for her to respond meaningfully. Judge Becerra expressed disappointment with the overall outcome and characterized the situation as a failure. He again asked Granjeno if he believed Moczygemba should be terminated, to which Granjeno replied, "No."

The jail's daily average was 569 for the week of August 3, 2025, with a peak of 578 inmates on August 5, 2025. The estimated cost for outsourcing inmates this week was \$132,715. The average number of outsourced males is 201 and females is 0. The week's inmates were housing in the following counties: Haskell.
