Discussion and possible action on the termination of all contracts with Flock Safety.

Allison Buess, Senior Felony Prosecutor with Hays County District Attorney's Office, made a public comment stating that Flock Safety cameras do not violate privacy laws and are often misunderstood. Roxanne Rodriguez, Chief Deputy County Clerk, read emailed public comments from the following individuals: Carin White, Melissa Deichmann, Robert McClelland, Darren McConville, Amy Milligan and Kinnison D Bryon in support of the Flock Safety cameras. Roxanne Rodriguez, Chief Deputy Clerk, read emailed public comments from the August 12, 2025 meeting from the following individuals: Tom Baum, Ana Juarez, Marcie Clark, Jacob Molina and Shirley Ogletree against the Flock Safety cameras. Commissioner Ingalsbe stated that two meetings have been held to discuss concerns and gather public input on this item. Ingalsbe added that, at this time, she is not prepared to support either the cancellation or the expansion of the Flock camera system. She stated that an additional meeting, including a representative from Flock, would be beneficial to address any outstanding questions. Commissioner Cohen questioned the legal implications of terminating the contract. Jordan Powell, First Assistant District Attorney - Civil Division, stated this would be an effective termination if terminated for convenience and would result in a \$3,000 cost. Cohen emphasized the need for additional information and supported the idea of having a Flock representative present at the next meeting. Commissioner Hammer stated that this item was initially brought before the court in February without contention and has only returned for a signature, and she questioned why it is now generating so much public input. Judge Becerra shared his concerns about federal overreach, stating that the situation involves a complex mix of constitutional issues and suggested a potential compromise could involve installing locally controlled cameras used exclusively by local law enforcement. The court had further discussion on this item. Commissioner Smith clarified that the system is funded through a rural law enforcement grant, which is restricted for use by law enforcement agencies. Smith stated his willingness to refrain from calling a vote at this time, noting the discourse surrounding the issue has shifted from constructive engagement. Smith questioned where the boundary line stops when it comes to data sharing, stressing that law enforcement officers work daily to protect the public and advocate for victims.



Judge Becerra concluded that the court would like more time to consider the issue and tabled the item to bring back at another court date. No action taken.

Vickie Dorsett, Budget Officer, presented the proposed FY26 budget including requests made during the Budget Workshop, excluding regrades. For new funding, Riparius Foundation requested \$160,000 and Hill Country Cottages Senior Center in Dripping Springs requested \$4,000. The court agreed that Elected Official salaries will be discussed separately. The court engaged in a discussion regarding current and future tax rates, exploring financial strategies connected to upcoming obligations. The court raised questions about the county's flexibility in managing funding limits, leading to a review of prioritized projects presented by Dorsett. The conversation focused on maintaining financial capacity through potential debt issuance without exceeding voter-approved thresholds. Commissioner Hammer emphasized the importance of considering how rate adjustments would affect local residents, particularly in terms of financial impact on homeowners. Dorsett informed the court that the NDS proposal included an additional funding requirement of \$474,230, of which \$250,000 has been secured, leaving a shortfall of \$224,000. The court continued discussions on the proposed tax rate, considering an increase to 0.3999. Dorsett also noted that \$50,000 in social service discretionary funding was available, with \$10,000 allocated per court member. Of this, \$25,000 was designated for Prevent A Litter (PALS), fulfilling their total funding request of \$60,000. Additionally, Judicial Services requested a \$500 uniform allowance, which the court approved. Chief Bailey, Deputy Sheriff, explained that the new Civil Service rules introduce a testing process that integrates written exams with assessment centers to evaluate candidates for specific roles and ranks. The Civil Service Commission plans to conduct comprehensive assessments and will need to initiate a bidding process. Dorsett estimated the total cost for these assessments to be approximately \$116,000. Dorsett reported that the Hays County Child Protective Board requested a reclassification for the Remme Rainbow Room Inventory Assistant position and a travel allowance of \$1,200. The court approved the travel allowance. In capital projects, there were things resulting in savings of \$74,376. Dorsett explained that the remaining items listed in the handout pertain to various departments, specifically those involving capital and non-capital computer equipment. She noted that all computer-related items have already been reviewed by the IT department, which has identified any necessary replacements. Dorsett explained that certain regrade requests were removed pending review by Human Resources. The remaining regrades pertain only to supervisory responsibilities or changes in job duties. The total cost of these adjustments is \$75,839, and the court approved the recommendation. Dorsett stated that with the NDS proposal changes, they are currently at a \$240,000 savings. The court agreed on a 3% raise on October 1 and a 3% on the employees' anniversary date. Commissioner Smith proposed reallocating the funds to various social service agencies as well as countywide agencies. The court approved a series of funding allocations totaling \$40,000 to various organizations: \$10,000 to Capital Idea, \$5,000 each to CITC, Community Action, CASA, Hays Caldwell Women's Center, and Hays County Child Protective Board, \$4,000 to Hill Country Cottages, and \$1,000 to the Dripping Springs Library. Additionally, the court agreed to \$1,500 for the District Clerk, \$13,000 for the Office of Emergency Services for an upfitted F-150 for the Fire Marshal, and a hazmat truck. The court also approved the hiring of a Financial Analyst for the Treasurer's Office, with a delayed start date of January 1, 2026. Dorsett stated that the only regrades included in the packet are those pending a comprehensive review of all positions by Human Resources. Candice Boutte, County Administrator, stated Vickie Dorsett, Commissioner Cohen and herself will be conducting the first round of budget director interviews, where they will lay out the vision and expectations. Dorsett informed the court of the remaining available funds totaling \$162,295 and reviewed the outstanding items still under consideration. She noted that not all these items would receive funding. The court agreed that more conversation was needed on the Fleet program but agreed to add one fire marshal. The court approved a restructuring of the District Clerk's Office, scheduled to take effect on January 1, 2026, with an associated cost of \$25,077 and one additional motor office for Constable Ellen, Precinct 5, effective April 1, 2026. A few items not related to the General Fund were discussed, which came from the Courthouse Security Fund and the Family Health Services fund. The court engaged in an extensive discussion regarding the salaries of elected officials, including a request from the Treasurer. Ultimately, the court decided to maintain the salary recommendations as outlined in the proposed budget. Erik Granjeno, Human Resources Director, noted that several elected



positions fall below the market average. However, the court decided to address all elected positions collectively and maintain the Treasurer's pay rate in line with the existing structure for other officials. Additionally, Countywide Operations requested reconsideration to fund a position in the Recycling Department by reallocating resources from planned Building Maintenance and Repairs projects.

Clerk's Note: Judge Becerra called for a recess and opened all Executive Session items at 5:31 p.m. and resumed back into open court at 6:45 p.m.

Vickie Dorsett, Budget Officer, provided the court with a court-approved packet highlighting the adjustments. She stated included in the packet is a new itemized tax rate of .3999 and the elected officials' salaries and allowances. Commissioner Ingalsbe stated at the final public hearing to adopt the FY2026 budget and levy the taxes will be held on September 16, 2025 at 1:00 p.m. in the Hays County Commissioners Courtroom, 111 E. San Antonio Street.

A motion was made by Commissioner Ingalsbe, seconded by Commissioner Cohen to accept the changes to the FY2026 proposed budget and set the FY2026 salaries and allowances as presented by the County Budget Officer.

Judge Becerra began the Budget Workshop at 11:47 a.m. Gina Alba-Rogers, Council for the Indigenous and Tejano Community (CITC) Chair, asked for \$35,000 and gave a video presentation on the organization. Anita Collins, CITC Treasurer and Director of Oral History-Videographer, mentioned an upcoming free screening of their visual history on the Cruz family on September 7, 2025. Ana Juarez spoke about the preservation of the San Pedro Cemetery. Vickie Dorsett, Budget Officer, discussed the county infrastructure needs. Dan Wegmiller, Hays County Financial Advisor, stated that Hays County will set out a notice of intent to issue on September 4, 2025, to go through the bond rating process and proceed with a sale on November 4, 2025, with proceeds delivered on November 25, 2025. David Wiley, Grant Consultant with Community Action, addressed the organization's inconsistent funding stream and asked for \$70,000. Cynthia Bentley, Public Relations for Kyle Area Senior Zone (KASZ), spoke about the organization and gave a presentation to the court asking for \$20,000. Amanda Calvert, Hays County District Clerk, asked for adjustments to the 2026 budget, to include 3 additional staff members and additional money for training. Mike Jones, Director of Emergency Services, requested additional staffing, vehicles, and technology. Tammy Crumley, Director of Countywide Operations, requested an additional staff member for the recycling facility that would work as a "floater". J.R. Mendoza, Justice of the Peace Precinct 2 Place 2, stated he is representing all the Justices of the Peace and requested salary increases for seven court administrators and 15 clerks. Stephanie Hunt, Purchasing Agent, requested a fleet coordinator position. Kandice Boutte, County Administrator, expressed the need for more internal conversations about the position. Shannon Anglero, Interim Executive Director of Neighborhood Defender Service (NDS) and Meenu Walter, Managing Director of NDS Texas, spoke about the organization's immediate needs and requested two attorneys and a supervisor investigator with the county covering salary, fringe, and the cost to house a team. Dorsett compared the 2023 actuals with the 2026 budget. Erik Granjeno, Human Resources Director, gave a presentation on a new 2026 benchmark study evaluating current compensation after the 2023 study to attract top talent with fair and competitive wages. He stated that of Hays County employees, 20% of employees were found to be above the market, 47% were below market, and 33% were at market. Granjeno presented three options aimed at alleviating inequities. Judge Becerra stated that option A would have the greatest impact. Commissioner Hammer



raised concerns about the efficiency of the step plan and noted that no merit-based increases have occurred since its implementation in 2023. Commissioner Smith commented that the current approach is an improvement over previous methods. Discussion followed regarding whether to implement the increase all at once or on each employee's work anniversary, including considerations related to funding differences. No action taken.
