Judge Becerra called the meeting to order.

PUBLIC COMMENTS

Alejandra Rodriguez, Deputy County Clerk, read an emailed public comment from Laura Nunn concerning publication wait times for polling locations on Election day.

4 2 4 3 8 Discussion and possible action to canvass the totals of the November 4, 2025, General Election.

Jennifer Doinoff, Hays County Elections Administrator, stated that the Election Board's responsibilities do not include publication of wait times. Doinoff stated the Hays election board was going through conversions, causing the lack of posting. Doinoff provided the court with historical facts for the Hays County Constitutional amendment. Judge Becerra stated the public had requested the Broadway polling location to become an early voting site and that Doinoff could share with the public what that would look like. Doinoff stated that the runoff elections are processed through the city and typically have only one early voting site. Commissioner Ingalsbe stated that it is a difficult situation, due to the Election's Office being the only early voting site.

A motion was made by Commissioner Ingalsbe, seconded by Commissioner Cohen to declare the results of the local canvass and approve the County election returns for the November 4, 2025, General Election, as presented by the Hays County Elections Administrator.
