Affidavit of Ownership & Volume of Gross Annual Food Sales

This document is not required to be filed or recorded with the Hays County Clerk's Office. This document must accompany any application in which the Owner of a food establishment (as defined by Texas Health & Safety Code, Chapter 437) is applying for a food establishment permit from Hays County. The document must be signed by the Owner of the food establishment in the presence of a Notary Public. If multiple Owners, an affidavit is required for each Owner.

Being the Owner or authorized agent of the food establishment applying with Hays County Development Services depose and say as follows:

4. Any materials, applications, or documents submitted with this affidavit as evidence were generated or collected by me or for me and are the original or exact duplicates of the original.
5. I acknowledge and agree to allow Hays County staff / personnel onto my property for the purpose of, including but not limited to, inspections, site assessments, site visits, or any other reasonable action to act upon the application(s).
6. I attest that the projected annual volume of food sales listed below is accurate and based upon previous years' actual volume of food sales information.
7. I understand and agree that Hays County may request verification of my previous year's actual volume of food sales.
