I hereby enter a plea of "no contest" on the above referenced offense. I have been informed of my rights to a trial; I waive my rights to a jury trial or hearing by the Court and discovery under T.C.C.P. Art. 39.14 and request the Court to allow me to complete a Driving Safety Course (DSC) for this case. I understand if I am under the age of 25 and did not get cited for the charges listed below, the court may grant "discretionary" DSC.

I swear and affirm that:

The charge offense involves a motor vehicle defined by Transportation Cod § 472.022, Subtitle C, Title 7, or Transportation Code § 729.001(a)(3), other than:

1. Speeding 25 miles per hour or more over the posted speed limit;
2. Failure to stop and provide information after an accident;
3. Failure to render aid after an accident;
4. Pass a school bus while loading or unloading children and;
5. An offense in a construction zone to which Transportation Code § 542.404 applies.

I swear and affirm that:

1. I am not in the process of taking a Driving Safety Course or Motorcycle Operator's Training Course and that I have not completed a Driver Safety Course or Motorcycle Operator's Training Course to have a case in any court in the State of Texas dismissed and no such course will appear on my driving record has having been completed within the last 12 months preceding the date of this offense;
2. I did not hold a Commercial Driver's License (CDL) and did not hold a CDL at the time that the offense occurred;
3. I am submitting a copy of my non-commercial Texas driver's license and A copy of valid proof of vehicle liability insurance, and I am listed as a driver on this policy and;
4. I have submitted the applicable filing fee which includes court costs and a non-refundable \$10.00 administrative fee.

**DRIVER SAFETY COURSE TOTAL FEE: \$144.00**

You have 90 days from the date the affidavit is notarized to take the course and submit both the DSC certificate of completion and a copy of your driving record to the court. The certificate must indicate it is for the Justice of the Peace Precinct One, Place One. The copy may be submitted to the court in person, by mailing it to Justice of the Peace, 1-1, 712 S. Stagecoach Trail, Ste. 2235, San Marcos, TX 78666 or via email at [jp1-1@hayscountytexas.gov](mailto:jp1-1@hayscountytexas.gov) .

You have 90 days to obtain and provide your driving record to the court. Driving Record Information: Obtain driving record (version 3 or 3A) from the Texas Department of Public Safety. The cost is \$10.00 plus credit card service fee. You may obtain your driving record via mail at: Texas Department of Public Safety, P.O. Box 149246, Austin, Texas 78714-9246 or online at: <https://txapps.texas.gov/tolapp/txlrcdr/TXDPSSLicenseeManager> . It is not necessary to wait for your driving record before attending a class.

I understand if I successfully complete the course **within 90 days of the date the affidavit is notarized**, my case will be dismissed. If I do not complete the terms of the Driving Safety Course, I will be scheduled for a Show Cause hearing to explain why I did not comply. If cause is not sufficient, I understand the Driving Safety privilege will be revoked and I will be found guilty of the offense. I understand that if found guilty, the conviction and violation will be reported to the Department of Public Safety to be placed on my driving record. **I understand if any amount is paid more than 30 days from date this affidavit is signed, I must pay the \$15 time payment reimbursement fee per Code of Criminal Procedure Act.**
