Opening Prayer

Approval of April Minutes: A motion to approve the April Pastoral Council Meeting Minutes, as presented, was made by Voorhees, then seconded by Wilcox. Motion carried with all saying Aye.

New Business:

• Approval of St. Patrick's Proposed 2025-2025 Budget: Justin Krieger, parish administrator/ bookkeeper, attended the meeting to answer questions from council members. A motion to approve the proposed 2025-2026 budget, as presented, was made by Ludwig, then seconded by Schaefer. Motion carried with all saying Aye.

• DMI Survey – opportunities for improvement:

- o Involving me in decisions that affect the future of the parish (14% disagree)
- Providing transparent information to me about the finances of the parish (15% disagree)
- Fr. shared that Diane Flaherty may want to do a workshop with the parish council, finance, and faith formation groups.
- Voorhees has observed an increase in young working families who are volunteering compared to 20 years ago. She has noticed that some employers are allowing for paid volunteer time as a benefit.

Committee Reports:

Members received meeting minutes/reports prior to the meeting to review, so the emphasis was on clarification questions. Questions or comments are noted within each respective group.

• Social Justice:

- o Matthew 25 Update:
 - Food Bank customers converted to a new system, training volunteers, as a result, payroll hours increased.

- Guevara shared that training involved using different phone messages, and using iPads to enroll people. USDA also had rule changes. The new system is also to help with the multiple churches helping the same people throughout the same month.
- In summary, Matthew 25 is experiencing increases in rules, increases in time, and increase in expenses (food). The program has a great crew of volunteers.
- Matthew 25 helps between 50-70 people per month.
- Liturgy: No update
- Faith Formation: Veit shared that the NCYC car wash last weekend did very well with free will donation. NCYC is seeing the largest number of students ever. Totus Tuus attendance was 40 children, 10 from Waverly, and 30 from our parish in grades 1-6. We were their first stop and did not have much time to share the program. Other parishes have waiting lists.
- **Finance Council:** No questions or concerns beyond the previously discussed budget review.
 - **School Board:** Schaefer reported that the school still has some openings for next school year to fill. Over the summer, upgrades to the intercom system will be made. All classrooms will have two-way communication with phones.
 - Marketing: No questions or concerns

 - Legacy Society: Not currently active, no update
