

## Program Guidelines and Compliance Requirements

### » MAGNET RMP

Aerial application of Magnet Insect Attractant Technology plus a registered insecticide (Magnet RMP) is an option that is available to certain Bollgard 3 cotton growers to improve their ability to comply with the Bollgard 3 RMP by removing the need for pupae destruction.

In addition, the Magnet RMP option provides several other benefits to cotton growers. However, continued availability of this technology requires strict compliance to the requirements for using Magnet RMP under the Bollgard 3 RMP.

### » COMPLIANCE REQUIREMENTS

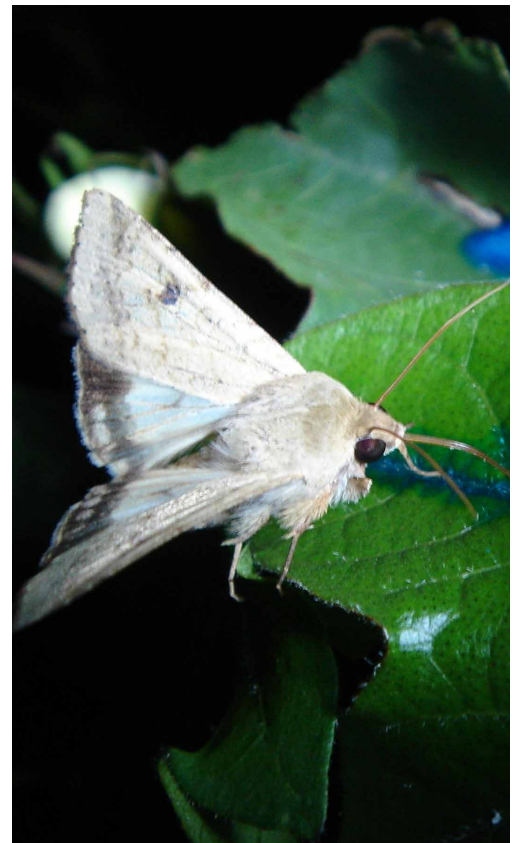
Compliance requirements include:

- ✓ Cotton growers must opt in via their Bollgard 3 Technology Service Provider (TSP) between 12 January 2026 and 31 January 2026.
- ✓ Three applications of Magnet RMP must be applied weekly, no earlier than 10 February 2026 and no later than 1 March 2026.
- ✓ Applications must be made by a Magnet RMP accredited aerial operator according to label directions.
- ✓ Magnet RMP applications must be traceable and recorded in the MTrack system.

### » PROCESS RESPONSIBILITIES

Over the page is the process for this year's Magnet RMP program, including compliance aspects and responsibilities of each stakeholder.
