## **ABOUT ATLANTIC AREA CASA, INC.**

**CASA (COURT APPOINTED SPECIAL ADVOCATES) IS A NONPROFIT ORGANIZATION DEDICATED TO ADVOCATING FOR ABUSED AND NEGLECTED CHILDREN PLACED IN FOSTER CARE, DURING A JUVENILE COURT PROCEEDING. ACCORDING TO STATE LAW, A CASA OR GUARDIAN AD LITEM (G.A.L.) SHOULD BE APPOINTED TO EACH CHILD FOUND TO BE DEPRIVED BY A JUVENILE JUDGE. HOWEVER, IN THE**

**ATLANTIC JUDICIAL CIRCUIT, THIS IS NOT THE CASE DUE TO A LACK OF VOLUNTEERS.**

**THESE CHILDREN NEED AN ADVOCATE THAT WILL STAND UP ON THEIR BEHALF. WITHOUT CASA VOLUNTEERS, MANY TIMES THESE CHILDREN ARE VOICELESS.**

**ATLANTIC AREA CASA, INC. IS AN AFFILIATE OF GEORGIA CASA. GEORGIA CASA IS A NONPROFIT ORGANIZATION WITH 47 COMMUNITY-BASED PROGRAMS THAT TRAIN AND SUPERVISE VOLUNTEERS TO ADVOCATE FOR CHILDREN WHO HAVE BEEN REMOVED FROM THEIR HOMES DUE TO ABUSE AND NEGLECT.**
