VICTIM COMPENSATION BOARD MEETING MINUTES

March 4, 2026

The Victim Compensation Board Meeting was held on March 4, 2026, at 2:00 p.m. in the first-floor conference room of the District Attorney's Office. The following Board Members were virtually present: Board Chair Katherine Daugaard, Board Members Robert Elliott and Bert Willman. The following Victim Compensation Staff were present in-person: Victim Compensation Administrator Amber Holland.
