### VICTIM COMPENSATION BOARD MEETING MINUTES

August 6, 2025

The Victim Compensation Board Meeting was held on August 6, 2025, at 10:00 a.m. in the first-floor conference room of the District Attorney's Office. ### **Other Business:**

- **Mental Health Policy:** The Board voted to table mental health discussions. Future discussions will include a review of holistic/spiritual modalities and how to implement evidence-based modalities.

- **Chiropractic Discussion:** The Board voted to change the chiropractic policy to allow the board to waive the requirement to begin treatment with 12 weeks on a case-by-case basis. The Board will consider up to 15 sessions. The session cap will replace the dollar cap.
- **Financial Review:** Scott Sosebee – Court Executive, provided a financial review. Board was notified that all vacant positions have been filled. The hiring freeze did not cause a substantial decrease in collections. However, there is a slight downward trend in CVC fund revenue. He also addressed that the JDA fund does not currently need to use administrative funds for personnel. However, this may change. If they are unable to utilize the administrative funds, they are agreeable to discuss supplementing for DA Admin expenses related to the CVC program or returning administrative funding to the main fund balance.
