VICTIM COMPENSATION BOARD MEETING MINUTES

December 11, 2025

The Victim Compensation Board Meeting was held on December 11, 2025, at 9:00 a.m. in the first-floor conference room of the District Attorney's Office. The following Board Members and Victim Compensation Staff were present: Board Chair Katherine Daugaard, Board Members Robert Elliott and Bert Willman, and Victim Compensation Administrator Amber Holland.

The Board meeting was called to order at 9:02 a.m. by Katherine Daugaard. A quorum of Board Members were in attendance for the meeting.
