New Business/Commissioner Comments

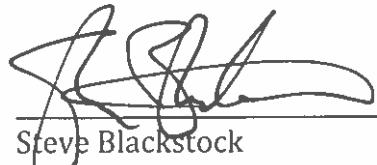
There was no new business, or additional Commissioner Comments.
