

Privacy Policy for Statewide Enterprises Inc.

I. INTRODUCTION

This Privacy Policy ("Policy") applies to information collected and controlled by Statewide Enterprises Inc. ("Statewide," "we," "us," or "our") through our websites and services (collectively, the "Sites"). Please read this Policy carefully, as it discloses our collection, storage, use, and disclosure of information collected through the Sites. Your use of the Sites is also subject to our Terms of Use.

Please note the arbitration provision set forth below, which may require you to arbitrate any claims you may have against Statewide on an individual basis. ARBITRATION ON AN INDIVIDUAL BASIS MEANS THAT YOU WILL NOT HAVE, AND YOU WAIVE, THE RIGHT FOR A JUDGE OR JURY TO DECIDE YOUR CLAIMS, AND THAT YOU MAY NOT PROCEED IN A CLASS, CONSOLIDATED OR REPRESENTATIVE CAPACITY.

THE SITE IS NOT INTENDED FOR CHILDREN AND STATEWIDE DOES NOT KNOWINGLY SOLICIT OR COLLECT PERSONAL INFORMATION ON THE SITE FROM CHILDREN UNDER THE AGE OF 13. IF STATEWIDE LEARNS THAT A CHILD UNDER THE AGE OF 13 HAS SUBMITTED PERSONALLY IDENTIFIABLE INFORMATION TO STATEWIDE THROUGH THE SITE, IT WILL TAKE REASONABLE MEASURES TO DELETE SUCH INFORMATION FROM ITS RECORDS AND TO NOT USE SUCH INFORMATION FOR ANY PURPOSE (EXCEPT WHERE NECESSARY TO PROTECT THE SAFETY OF THE CHILD OR OTHERS, AS REQUIRED BY LAW, OR AS MAY OTHERWISE BE REQUIRED BY LAW).

II. YOUR CONSENT AND POLICY CHANGES.

PLEASE READ THIS ENTIRE PRIVACY POLICY CAREFULLY. BY USING THE SITE, YOU EXPRESSLY CONSENT, WITHOUT QUALIFICATION, TO THE COLLECTION, USE AND DISCLOSURE OF INFORMATION, INCLUDING PERSONAL INFORMATION, AS DESCRIBED IN THIS PRIVACY POLICY. IF YOU DO NOT AGREE TO THE TERMS OF THIS PRIVACY POLICY, YOU ARE NOT AUTHORIZED TO USE THE SITE.

Statewide may amend this Privacy Policy from time to time. We will post those changes on the website or update the Privacy Policy date below. In certain cases, you will be notified via email or by a notice on our website.

III. INFORMATION COLLECTED

We collect two types of information from visitors to our Sites: (i) Personal Information and (ii) Non-Personal Information. "Personal Information" is any information that identifies, relates to, describes, is capable of being associated with, or could reasonably be linked, directly or indirectly, with a particular identified or identifiable natural person or household. "Non-Personal Information" includes information that is outside the scope of Personal Information, as well as publicly available information lawfully made available

from federal, state, or local government records, or Personal Information that has been de-identified or aggregated. Please note that over time, Non-Personal Information may become Personal Information due to regulatory developments, technological advancements, or the co-mingling of Personal and Non-Personal Information.

We will retain Personal Information provided for as long as it is needed to fulfill the purpose for which it is collected.

We may collect the following categories of information from and about you:

1. **Identifiers:** This may include name, alias, postal address, unique personal identifier, online identifier, Internet Protocol address, email address, account name, Social Security number, driver's license number, passport number, or other similar identifiers.
 - **Source(s):** Directly from you; Indirectly from you (e.g., from observing your actions on our Sites); From third party service providers (e.g., those that assist with background checks and providing other pertinent information)
 - **Purpose(s):** To fulfill or meet the reason you provided the information, e.g., when you contact us with a question or request further information about a property, when you register to pay rent online, or when you apply for a job with us; Marketing
 - **Disclosure to Third Parties:** Disclosure for business purposes to payment processors; administrative services; third parties who assist with processing job applications and recruiting; fraud detection assistance; credit check company
2. **Personal Information Categories Listed in the California Customer Records Statute:** This may include name, signature, Social Security number, physical characteristics or description, address, telephone number, passport number, driver's license or state identification card number, insurance policy number, education, employment, employment history, bank account number, credit card number, debit card number, or any other financial information, medical information, or health insurance information.
 - **Source(s):** Directly from you; From third party service providers
 - **Purpose(s):** To fulfill or meet the reason you provided the information, e.g., when you contact us with a question or request further information about a property, when you register to pay rent online or when you apply for a job with us; Marketing
 - **Disclosure to Third Parties:** Disclosure for business purposes to payment processors; administrative services; third parties who assist with processing job applications and recruiting; fraud detection assistance; credit check company
3. **Protected Classification Characteristics Under California or Federal Law:** This may include age (40 years or older), race, color, ancestry, national origin, citizenship, religion or creed, marital status, medical condition, physical or mental disability, sex (including gender, gender identity, gender expression, pregnancy or

childbirth and related medical conditions), sexual orientation, veteran or military status, genetic information (including familial genetic information).

- **Source(s):** Directly from you; From third party service providers (e.g., those that assist with background checks and providing other pertinent information)
 - **Purpose(s):** To fulfill or meet the reason you provided the information, e.g., to process employment applications

4. **Professional or Employment-Related Information:** This may include current or past job history or performance evaluations.
- **Source(s):** Directly from you; From third party service providers (e.g., those that assist with background checks and providing other pertinent information)
 - **Purpose(s):** To fulfill or meet the reason you provided the information, e.g., to process employment applications
 - **Disclosure to Third Parties:** Disclosure for business purposes to background check providers, third parties who assist with processing job applications, and recruiting
5. **Commercial Information:** This may include records of personal property, products or services purchased, obtained, or considered, or other purchasing or consuming histories or tendencies .
- **Source(s):** Directly from you; From third party service providers (e.g., those that assist with credit checks and providing other pertinent information)
 - **Purpose(s):** To fulfill or meet the reason you provided the information, e.g., to respond to an inquiry or process your request; Marketing
 - **Disclosure to Third Parties:** Disclosure for business purposes to payment processors and delivery services
6. **Biometric Information:** This may include audio, electronic, visual, thermal, or other similar information .
- **Source(s):** Directly from you
 - **Purpose(s):** To fulfill or meet the reason you provided the information, e.g., for identification record-keeping, and administrative and/or security purposes
 - **Disclosure to Third Parties:** N/A
7. **Internet or Other Similar Network Activity:** This may include browsing history, search history, information on a consumer's interaction with a website, application, or advertisement .
- **Source(s):** Indirectly from you (e.g., from observing your actions on our Sites); From third party service providers
 - **Purpose(s):** To fulfill or meet the reason you provided the information, e.g., to improve our services; Marketing

- **Disclosure to Third Parties:** Disclosure for business purposes to internet service providers; payment processors; fraud detection assistance
- 8. **Geolocation Data:** This may include physical location or movements .
 - **Source(s):** Directly from you; Indirectly from you (e.g., from observing your actions on our Sites)
 - **Purpose(s):** To fulfill or meet the reason you provided the information, e.g., to respond to an inquiry; Marketing
 - **Disclosure to Third Parties:** Disclosure for business purposes to internet service providers
- 9. **Inferences Drawn from Other Personal Information:** This may include a profile reflecting a person's preferences, characteristics, psychological trends, predispositions, behavior, attitudes, intelligence, abilities, and aptitudes .
 - **Source(s):** Indirectly from you (e.g., from observing your actions on our Sites); From third party service providers
 - **Purpose(s):** To fulfill or meet the reason you provided the information; Marketing
 - **Disclosure to Third Parties:** N/A

IV. USE OF INFORMATION COLLECTED

We may use your personal information for the following purposes:

- To deliver our Services or information you have requested;
- Verify your authority to enter certain password protected areas of the Site or Services;
- Verify that you are a customer or prospective customer;
- Send you information that you have signed up to receive, notices about our products and/or Services that you have used or that may be of interest to you and notices about events;
- Improve the content and general administration of the Site and our Services;
- Auditing related to counting ad impressions to unique visitors, verifying positioning and quality of ad impressions, and auditing compliance with this specification and other standards;
- Helping to ensure security and integrity to the extent the use of personal information is reasonably necessary and proportionate for these purposes;
- Debugging to identify and repair errors that impair existing intended functionality;
- Short-term, transient use, including, but not limited to, non-personalized advertising shown as part of your current interaction with us, provided that personal information is not disclosed to another third party and is not used to build a profile about you or otherwise alter your experience outside the current interaction with us;
- Undertaking internal research for technological development and demonstration;
- Undertaking activities to verify or maintain the quality or safety of the Site, Services, or device that is owned, manufactured, manufactured for, or controlled

by us, and to improve, upgrade, or enhance the Site, Services, or device that is owned, manufactured, manufactured for, or controlled by us;

- With your consent or authorization; and
- For our legitimate business purposes unless otherwise prohibited by law.
- If you are a user of our Services, we may use your personal information to provide these Services to you.

V. SHARING AND DISCLOSURE OF INFORMATION COLLECTED

We may share or disclose your Personal Information in the following instances and to the following parties:

- To third-party service providers, agents, or independent contractors who help us maintain our Sites and provide other administrative services to us.
- To third parties that control property-specific websites.
- To third-party payment processors that process rent payments for us.
- To a third-party job applicant and recruiting manager that manages our job application and recruiting process.
- To third parties as part of any corporate reorganization process including, but not limited to, mergers, acquisitions, and sales of all or substantially all of our assets.
- To law enforcement in order to comply with the law or in the good faith belief that such action is necessary in order to conform to the requirements of the law or comply with legal process served on us, protect and defend our rights or property, or act in urgent circumstances to protect the personal safety of our end users.
- To protect against potential fraud, we may verify with third parties the information collected from the Sites.

VI. COOKIES AND OTHER SIMILAR TECHNOLOGIES

We use, and allow certain third parties to use, cookies and other similar technologies to provide our Sites and services, and to help collect information. We, or third parties, may use session cookies or persistent cookies. Session cookies only last for the specific duration of your visit and are deleted when you close your browser. Persistent cookies remain on your device's hard drive until you delete them or they expire. We use the following types of cookies:

- **Essential.** Some cookies are essential in order to enable you to move around our Sites and use their features. Without these cookies, we cannot enable appropriate content based on the type of device you are using.
- **Browsing and Functionality.** These cookies allow us to remember choices you make on the Sites, such as your preferred language, and provide enhanced, more personalized features.

Performance and Analytics. Our Sites use Google Analytics, a web analytics service provided by Google, Inc. ("Google"). The information generated by the Google Analytics cookie about your use of the Sites will be transmitted to and

stored by Google on servers in the United States. Google will use this information for the purpose of evaluating your use of the website, compiling reports on website activity for website operators and providing other services relating to website activity and internet usage. Google may use the data collected to contextualize and personalize the ads of its own advertising network. Google may also transfer this information to third parties where required to do so by law, or where such third parties process the information on Google's behalf. Google will not associate your IP address with any other data held by Google. You can opt-out of the Google Analytics Advertising Features we use by indicating your preference using the interest-based opt-out link [here](#). Google also provides a complete privacy policy and instructions on opting-out of Google Analytics [here](#)

Please check your browser and browser settings to determine where cookies are stored and whether and how they may be deleted. The Network Advertising Initiative also offers a means to opt-out of a number of advertising cookies. Please visit networkadvertising.org to learn more. Note that opting-out does not mean you will no longer receive online advertising. It does mean that the company or companies from which you opted-out will no longer deliver ads tailored to your preferences and usage patterns. In any event, if you reject our cookies, you may still use the Sites, but some of the Sites' features may be limited.

VII. EMAIL AND TEXT MANAGEMENT.

You may receive emails and texts from Statewide for a variety of reasons. We respect your desire to manage email and text correspondence. You can also manage your receipt of certain types of communication by following the instructions included in the email we send you. Please note that, even if you unsubscribe from certain email correspondences, we may still need to email you with information relating to your unit, the management of the property, and other important transactional or administrative information.

VIII. AGGREGATE INFORMATION

The Site and Services may track the total number of visitors to our Site and Services, the number of visitors to each page of our Site, browser type, IP addresses, External Web Sites (defined below) linked to and other aggregated data collected through our Services and we may analyze this data for trends and statistics in the aggregate but such information will be maintained, used and disclosed in aggregate form only and it will not contain personal information. We may use such aggregate information to analyze trends, administer the Site and Services, track users' movement, and gather broad demographic information for aggregate use.

If we deidentify your personal information, we publicly commit to retain and use the deidentified personal information without attempting to reidentify the deidentified personal information.

IX. USE OF INFORMATION COLLECTED

We use the information collected on the Sites for the following purposes:

- To provide and improve the Sites and our services;
- To provide information about the properties we manage;
- To respond to inquiries and with your consent;
- To track and analyze your usage of the Sites;
- To compile user information for marketing purposes, advertising, conducting marketing analysis, providing you with recommendations for products or services based on your profile, and promotional material planning and distribution;
- To receive and administer rent payments;
- To process employment applications; and
- For other legitimate business purposes.

X. SHARING AND DISCLOSURE OF INFORMATION COLLECTED

We may share or disclose your Personal Information in the following instances and to the following parties:

- To third party service providers, agents or independent contractors who help us maintain our Sites and provide other administrative services to us;
- To third parties that control property-specific websites;
- To third party payment processors that process rent payments for us;
- To a third party job applicant and recruiting manager that manages our job application and recruiting process;
- To third parties as part of any corporate reorganization process including, but not limited to, mergers, acquisitions and sales of all or substantially all of our assets;
- To law enforcement in order to comply with the law or in the good faith belief that such action is necessary in order to conform to the requirements of the law or comply with legal process served on us, protect and defend our rights or property, or act in urgent circumstances to protect the personal safety of our end users; and
- To protect against potential fraud, we may verify with third parties the information collected from the Sites.

XI. COLLECTION AND USE OF INFORMATION FROM CHILDREN

The Sites are directed to persons 18 years of age or older. We do not knowingly collect, distribute, or share any information from persons under 18 years of age. If we become aware that a child under 18 years of age has provided information to us, we will delete such information as soon as possible.

XII. ACCESS AND OPT-OUT

If you have an account on our Sites, you can access and edit the information you provided to us through individual settings on the Sites.

If you no longer wish to receive marketing communications from us, you can opt-out by following the unsubscribe instructions provided in the marketing communication or by contacting us at [Phone Number] or [E-mail Address] We will process your unsubscribe as soon as possible, but please be aware that in some circumstances you may receive a few more messages until the unsubscribe is processed.

Please note that even if you opt-out of marketing communications, we will still send you transactional and administrative messages regarding the Sites, including, for example, necessary notifications, administrative confirmations, important updates regarding the Sites, and notices regarding this Privacy Policy.

XIII. THIRD-PARTY LINKS AND SOCIAL MEDIA PLUG-INS

Our Sites may contain links to third-party websites. When you visit the website for a specific property, that website is controlled by a third party. When you pay rent, you do so through a website controlled by a third party. When you click on a job opening at Statewide, you are directed to a third party website. We are not responsible for the privacy practices or content of such other websites. If you have any questions about how these other websites use your information, you should review their policies and contact them directly.

The Sites also offer you the ability to interact with plug-ins from the following social media sites: Facebook, Twitter, Instagram, Pinterest, Google+ and LinkedIn. Statewide may know that you clicked on a social plug-in or receive other information from these social media sites. Similarly, if you have previously provided Personal Information to a third party operating a plug-in on the Sites, then this third-party may recognize you on the Sites. Your use of social network plug-ins is subject to each social media site's privacy policy and other terms and conditions, which may be different from ours, so please read these policies carefully to understand their policies and your options. As with linked sites, Statewide has no control over the information that is collected, stored, or used by social network plug-ins.

XIV. ACCESSING, REVIEWING AND CHANGING YOUR CONTACT INFORMATION.

As an account holder, you can see, review and change most of your contact information associated with your Account Profile by logging into your account and editing your Account Profile. For assistance, you may contact us using one of the methods listed below. With some exceptions, you have the right to see what Personal Information we hold about you. We can help you identify what records we might have about you. We may need to confirm your identity before providing you with this access, and if we cannot verify your identity with the degree of certainty required, we will not be able to respond to your request. If we cannot give you access, we will tell you within 45 days of receipt of your request and provide you with a reason, as best we can, as to why we cannot give you access.

XV. NOTICE REGARDING PUBLIC POSTING AREAS

Please note that any information you include in a message you post to any chat room, forum or other public posting area is available to anyone with Internet access. If you do not want people to know your email address, for example, do not include it in any message you post publicly. PLEASE BE EXTREMELY CAREFUL WHEN DISCLOSING ANY INFORMATION IN CHAT ROOMS, FORUMS AND OTHER PUBLIC POSTING AREAS. WE ARE NOT RESPONSIBLE FOR THE USE BY OTHERS OF THE INFORMATION THAT YOU DISCLOSE IN CHAT ROOMS, FORUMS AND OTHER PUBLIC POSTING AREAS.

XVI. MINOR'S PRIVACY

Statewide Enterprises Inc. recognizes the privacy interests of children and we encourage parents and guardians to take an active role in their children's online activities and interests. Neither our Site nor our Services are intended for children under the age of 18. Statewide Enterprises Inc. Partners, Inc. does not target its Services or this Site to children under 18. Statewide Enterprises Inc. does not knowingly collect personal information from children under the age of 18. By using our Site and Services, you represent that you are not under 18 years of age.

XVII. SECURITY

No data transmissions over the Internet can be guaranteed to be 100% secure. Consequently, we cannot ensure or warrant the security of any information you transmit to us and you understand that any information you transfer to Statewide is done at your own risk. Once we receive your transmission, we make reasonable efforts to ensure security on our systems. If we learn of a security systems breach, we may attempt to notify you electronically so that you can take appropriate protective steps. By using the Sites or providing Personal Information to us, you agree that we can communicate with you electronically regarding security, privacy and administrative issues relating to your use of the Sites. We may post a notice on our Sites if a security breach occurs. We may also send an email to you at the email address you have provided to us in these circumstances. Depending on where you live, you may have a legal right to receive notice of a security breach in writing.

We recommend that you take additional measures to protect yourself, including by installing anti-virus software, closing browsers after use, keeping your passwords confidential, and making sure that you regularly update software and apps. If you have reason to believe that the Personal Information that we have collected or our system security has been breached, please promptly notify us through the email address provided in the Contact section at the end of this Privacy Policy.

XVIII. ASSIGNMENT

In the event that all or part of our assets are sold or acquired by another party, or in the event of a merger, you grant us the right to assign the Personal and Non-Personal Information collected about you via the Sites.

XIX. DISPUTE RESOLUTION AND AGREEMENT TO ARBITRATE

Except where and to the extent prohibited by law, by using the Sites, you and Statewide agree that, if there is any controversy, claim, action, or dispute arising out of or related to your use of the Sites, or the breach, enforcement, interpretation, or validity of this Privacy Policy or any part of it ("Dispute"), both parties shall first try in good faith to settle such Dispute by providing written notice to the other party describing the facts and circumstances of the Dispute and allowing the receiving party thirty (30) days in which to respond to or settle the Dispute. Notice shall be sent to:

- You, at the address we have on file for you.

Both you and Statewide agree that this dispute resolution procedure is a condition precedent that must be satisfied before initiating any litigation or filing any claim against the other party. IF ANY DISPUTE CANNOT BE RESOLVED BY THE ABOVE DISPUTE RESOLUTION PROCEDURE, YOU AGREE THAT THE SOLE AND EXCLUSIVE JURISDICTION FOR SUCH DISPUTE WILL BE DECIDED BY BINDING ARBITRATION ON AN INDIVIDUAL BASIS. ARBITRATION ON AN INDIVIDUAL BASIS MEANS THAT YOU WILL NOT HAVE, AND YOU WAIVE, THE RIGHT FOR A JUDGE OR JURY TO DECIDE YOUR CLAIMS, AND THAT YOU MAY NOT PROCEED IN A CLASS, CONSOLIDATED, OR REPRESENTATIVE CAPACITY. Other rights that you and we would otherwise have in court will not be available or will be more limited in arbitration, including discovery and appeal rights. All such disputes shall be exclusively submitted to [Arbitration firm e.g JAMS or ADR] for binding arbitration under its rules then in effect, before one arbitrator to be mutually agreed upon by both parties.

The arbitrator, and not any federal, state, or local court or agency, shall have exclusive authority to resolve any dispute arising under or relating to the interpretation, applicability, enforceability, or formation of this Privacy Policy, including any claim that all or any part of this Privacy Policy is void or voidable.

XX. CHOICE OF LAW

This Privacy Policy has been made in, and shall be construed in accordance with, the laws of the State of California, without giving effect to any conflict of law principles. The parties acknowledge that this Privacy Policy evidences a transaction involving interstate commerce. Notwithstanding the provision in the preceding paragraph with respect to applicable substantive law, any arbitration conducted pursuant to the terms of this Privacy Policy shall be governed by the Federal Arbitration Act (9 U.S.C. §§ 1-16).

XXI. YOUR CALIFORNIA PRIVACY RIGHTS

California Civil Code Section 1798.83 permits visitors to the Sites who are California residents to request certain information regarding our disclosure of Personal Information to third parties for their direct marketing purposes. However, we do not share your data with third parties for their direct marketing at this time.

From January 1, 2020, California consumers have the following rights. To the extent that these rights apply to you, the following rights are provided:

- **Obtain Access to and Portability of Your Personal Information**, including: (i) confirming whether we are processing your personal information; (ii) obtaining access to or a copy of your personal information including specific pieces of personal information; and (iii) receiving an electronic copy of personal information that you have provided to us, or asking us to send that information to another company in a structured, commonly used, and machine readable format.
 - Any copy of personal information provided will be in a portable and, to the extent technically feasible, readily usable format that will allow you to transmit the personal information to another person.
- **Request Access to Your Personal Information**, including that we disclose to you, free of charge, the following:
 - The categories of personal information, including sensitive personal information, that we have collected about you.
 - The categories of sources from which the personal information, including sensitive personal information, is collected.
 - The business or commercial purpose for collecting or selling or sharing personal information, including sensitive personal information.
 - The categories of third parties with whom we disclose personal information, including sensitive personal information, which may include a list of specific third parties, other than natural persons, to which we have disclosed personal information.
 - The specific pieces of personal information, including sensitive personal information, we have collected about you, which may include a copy of all personal information we are processing or have processed.
- **Request Correction** of your personal information where it is inaccurate or incomplete (subject to exceptions as permitted by applicable law). When correcting inaccuracies, we will take into account the nature of the personal information and the purpose for processing the personal information.
- **Request Deletion** of your personal information (subject to exceptions as permitted by applicable law).
- **Request Disclosure of Your Personal Information**, including that we disclose to you, free of charge, with respect to personal information that we sell or disclose for a business purpose:
 - The categories of personal information, including sensitive personal information, that we have collected about you.
 - The categories of personal information, including sensitive personal information, that we have sold about you and the categories of third parties to whom the personal information was sold, by category or categories of personal information for each third party.
 - The categories of personal information, including sensitive personal information, that we have disclosed about you for a business purpose.
- **Request Restriction of or Object to** our processing of your personal information where the processing of your personal information is based on our

legitimate interest or for direct marketing purposes, including (i) the right to opt-out of the sale or sharing of personal information, (ii) object to or restrict our use of or your sensitive personal information, including the right to opt-out of the use and disclosure of sensitive personal information, and (iii) opt out of the processing of your personal information for purposes of (a) targeted advertising, and (b) profiling in furtherance of automated decisions that produce legal or similarly significant effects concerning you. Such opt-out right may be available through an opt-out preference signal.

- If your personal information is profiled in furtherance of automated decisions that produce legal or similarly significant effects, you may have the right to question the result of the profiling, to be informed of the reason that the profiling resulted in the decision, and, if feasible, to be informed of what actions you might have taken to secure a different decision and the actions that you might take to secure a different decision in the future. You may have the right to review your personal Information used in the profiling. If the decision is determined to have been based on inaccurate personal information, you may have the right to have the information corrected and the profiling decision reevaluated based on the corrected information.
- **Opt-out of Sale or Sharing for Cross-Contextual Advertising.** Although we do not “sell” your personal information as the term “sale” is typically understood, we may “share” your information for cross-context behavioral advertising with analytics providers and advertising networks in order to understand how visitors use our websites and serve you ads on and off our websites. Such opt-out right may be available through an opt-out preference signal.
- **Right to non-discrimination**
You have the right to not be discriminated against for exercising any of these rights.
