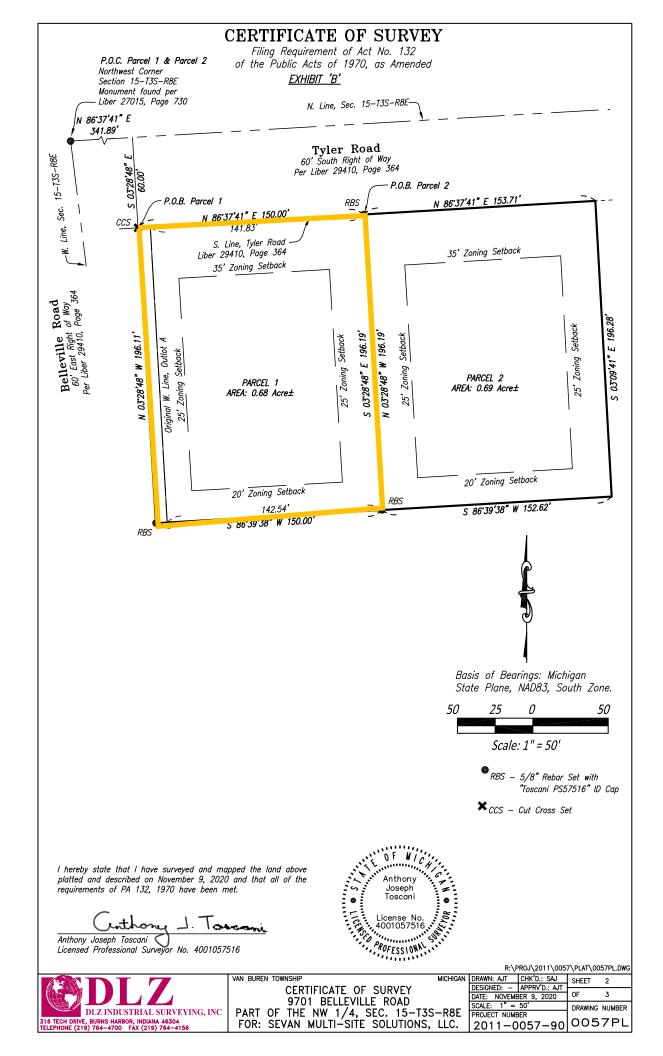

Part of the Northwest Quarter of Section 15, Township 3 South, Range 8 East, Van Buren Township, Wayne County, Michigan being more particularly described as follows:

Commencing at the Northwest corner of said Section 15; thence North 86 degrees 37 minutes 41 seconds East (this and all subsequent bearings are referenced to the Michigan State Plane Coordinate System of 1983, South Zone), 341.89 feet along the north line of said Northwest Quarter; thence South 3 degrees 28 minutes 48 seconds East, 60.00 feet to the south line of a Parcel described to the Board of County Road Commissioners of the County of Wayne in a Grant of Right of Way document recorded in Liber 29410, Page 364, Wayne County Records and the POINT OF BEGINNING; thence North 86 degrees 37 minutes 41 seconds East, along said south line, 150.00 feet; thence South 3 degrees 28 minutes 48 seconds East, 196.19 feet; thence South 86 degrees 39 minutes 38 seconds West, 150.00 feet; thence North 3 degrees 28 minutes 48 seconds West, 196.11 feet to said south line of the County Road Commissioners Parcel and the Point of Beginning, containing 0.68 acre, more or less.

Parcel 2:

Part of the Northwest Quarter of Section 15, Township 3 South, Range 8 East, Van Buren Township, Wayne County, Michigan being more particularly described as follows:

Commencing at the Northwest corner of said Section 15; thence North 86 degrees 37 minutes 41 seconds East (this and all subsequent bearings are referenced to the Michigan State Plane Coordinate System of 1983, South Zone), 341.89 feet along the north line of said Northwest Quarter; thence South 3 degrees 28 minutes 48 seconds East, 60.00 feet to the south line of a Parcel described to the Board of County Road Commissioners of the County of Wayne in a Grant of Right of Way document recorded in Liber 29410, Page 364, Wayne County Records; thence North 86 degrees 37 minutes 41 seconds East, 150.00 feet along said south line to the POINT OF BEGINNING; thence North 86 degrees 37 minutes 41 seconds East, along said south line, 153.71 feet; thence South 3 degrees 09 minutes 41 seconds East, 196.28 feet; thence South 86 degrees 39 minutes 48 seconds West, 152.62 feet; thence North 3 degrees 28 minutes 48 seconds West, 196.19 feet to said south line of the County Road Commissioners Parcel and the Point of Beginning, containing 0.69 acre, more or less.

Surveyor's Notes:

- 1. The description for Outlot "A" shown on Sheet 1 is the description of Outlot "A" prepared by SSOE, Inc. as Project No. 006120-03.
- 2. The description for Outlot "A" has a different basis of bearings from this survey. The rotation angle between the bearings shown on Sheet 1 and the bearings shown on this survey is 01:13'09" in a counter-clockwise direction.
- 2. This plat represents a survey of a new parcel (Parcel 1) to be cut from the Outlot "A" (Meijer, Inc). A description of the remainder of Outlot "A" has also been prepared.
- 3. Parcel Numbers shown hereon were obtained from the Wayne County GIS.
- 4. Any easements that may lie on these parcels are not shown.
- 5. Last date of fieldwork: September 4, 2020.
- 6. The ratio of closure of the unadjusted field observations for this survey did not exceed 1 foot in 5000 feet.
