MINUTES (APPROVED)

I. Call to Order

The Board Meeting was called to order at 4:000 p.m. by Bob Johnson of Integrated Mountain Management.

II. Verification of Quorum

- **b.** Rules and Regulations Changes IMM to add Decks, Patios, and Hottubs, to Rules and Regulations and and reference existing documents as exhibits. Addition of weight limits to be added to "Residential Parking" was requested.
- **c. Bear Education** Mike reported that signs with bear education have been placed on dumpsters. IMM to send email to membership as reminder that pumpkins are not to be placed outdoors.

VII. Construction Requests

- **a. Unit 251 Sump Pump Project** Unit 251 updated that they are in search of plumber to complete repairs to be done. Sump Pump model was approved to aid in drying out crawlspace. They will provide a landscaping plan to be reviewed to create a berm to deter water.
- **b. 30 Meadow Ranch approval request for planting tree shrub bushes** Project was approved contingent on the placement of the three plants. Location will be determined in the Spring before digging.

Mike brought forth discussion on dying Austrian Pine. It was decided not to remove. Mike to provide contract from Save A Tree to Borad to review terms. Gerry inquired on having grass seeded possibility during the Fall. Mike to follow up with Greenscape.
