# BOD Meeting convened at 4:00 pm by Chip Gerber

## **Homeowner comments:**

Anne Pirzadeh asked if there were any updates on the St Finnbar litigation.

Dave Carrera also asked if the BOD could shed any light on the St Finnbar litigation, Chip Gerber explained the issue was their desire to access BLM land through our easement.

Rick Ballentine offered to be available for any discussion on fire mitigation at the Ranch. He also offered his support for moving forward with EV charging stations.

Pete Stuart offered assistance with the proposed Tom Vail memorial plaque that would be placed near the 6<sup>th</sup> tee box on the golf course.

**Infrastructure**: Chip Gerber reported that he had engaged with SGM Engineering regarding a paving audit. Timeframe for work looks like Sep/Oct '24.

**Condos**: Jason Fitzhugh briefed the BOD on the EV charging station initiative background and mentioned that a new survey will be sent to the community.

# Ranch Manager's Report:

Gray reported legal expenses of approximately \$119k since Oct '21 on St Finnbar litigation.

Due to FWAC work done on Kingfisher Bend area, there is some damage to the paths that will be repaired, please be careful in those areas.

Thank you, Ranch Staff, the shop overhang project is halfway finished.

Awaiting 2 more bids on road paving project.

Daly will be on the Ranch the end of April to work on landscaping.

Fish stocking will occur on the 18th of April.

One of the wooden fishing signs on the Ranch is being refurbished.

A nutrient analysis at the WWTP is pending.

Monarch will be doing warranty work on the condos.

Ranch management will be exercising remote workdays.

## **Old Business:**

**Andrew Yager** suggested discontinuing our relationship with Law Firm Karp, Neu, and Hanlon. He also asked about improving yield on our cultivated grasses that we have harvested. He asked that any utilities exposed on the Ranch be covered. He asked how many EQR's were in use and

how many were sold. Gray reported 311 owned, 249 connected with a max number of 340 which leaves 29 remaining. He also asked for a speedbump review.

The next HOA BOD meeting was scheduled for Monday, May 13, 2024, at 4:00 pm.
