# **VI.** Board Topics

- 353 Stagecoach Lane Easement update
  - Propose a five foot easement from the BOD so that they don't need to re-draw all of the plans
    - Previously BOD approved reducing the easement variance from 20' to 10'
  - o BOD will follow up with law team before deciding
- Governing Documents HOA Declarations Document rollout plan
  - o Anne: Plan to roll-out the new document revised from the 1985 version
    - BOD will follow Colorado Common Interest Ownership Act (CCIOA) requirements

# RANCH AT ROARING FORK

- There will be two mailings. First with the draft version of new Declarations with a cover letter and a summary of changes and instructions hopefully this month (September), the second with any further changes as a final version for HOA to approve
- During the 30 day FAQ timeframe, there will be lots of communication through the office and the volunteer committee so that everyone knows what is happening and when they need to have questions submitted, attend meetings and vote
- Draft version of the Declarations will be posted on the website
- There will be 30 days for review and 90 days for homeowners to vote
- Questions and comments from homeowners need to be submitted to office to give to Wilson Anderson (lawyer) 30 days prior to zoom meetings so that he can review
- There will be two zoom meetings for Q&As: October 21 at 6:30 and November 8 at
  6:30. Invitations will be sent via the office
- A committee will be assembled to assist with roll-out and informing the HOA
- A community in favor vote of 67% is required for this version of the declarations to pass
- November 25 voting will begin and be available via email and mail
- Security Camera Pilot
  - Bill: Security camera at the maintenance barn gate to monitor vehicle and foot traffic, collect data and see if we need additional cameras around the Ranch.
    - Not to exceed \$300 for a three month trial
    - Office will be responsible to review footage daily and see if there are causes for concern

    - Andrew will build a site on the back end to roll-out afterwards

  - Chip: will find an outside company come in and repair and/or stain the current benches
    - The funds will come from the golf budget
